

UNIVERSAL TECHNICAL INSTITUTE – MIRAMAR GRANT OPPORTUNITIES

ELIGIBLE DATES: VALID FOR AUGUST 25, 2025, THRU SEPTEMBER 30, 2025, START DATES

Unlike a loan, a grant does not have to be repaid. The Institutional Grant and Relocation Grant are designed to assist students who have the greatest financial need. The grant amount is based on financial need. The maximum can change each award year and depends on program funding.

10% INSTITUTIONAL GRANT

This grant is to assist students who are in the greatest financial need and are relocating or commuting 50 miles or greater to attend UTI by reducing their overall tuition.

GENERAL ELIGIBILITY CRITERIA

- Relocating or commuting 50 or more miles daily to campus*
- Enrolled more than 30 days prior to start date
- Have an SAI (Student Aid Index) of 8,000 or less

EXCLUSIONS

- Students receiving the Relocation Grant
- Students receiving the Salute to Service Grant
- Students receiving the 10% Technical Education Institutional Grant
- Students receiving any other UTI-funded, need-based scholarship, grant or tuition reduction
- Laptop, Lab Fee and Meter Fee coverage

RELOCATION GRANT

This grant is to assist students who are in the greatest financial need and are relocating or commuting 50 miles or greater to attend UTI by subsidizing costs associated with relocation, housing or making long commutes back and forth to school. The grant allows students to focus on academics and gaining local employment, helping set them up for long-term success.

GENERAL ELIGIBILITY CRITERIA

- Relocating or commuting 50 or more miles daily to campus*
- Enrolled more than 30 days prior to start date
- Have an SAI (Student Aid Index) of 8,000 or less

EXCLUSIONS

- Students receiving the Institutional Grant
- Students receiving the Salute to Service Grant
- Students receiving the 10% Technical Education Institutional Grant
- Students receiving any other UTI-funded, need-based scholarship, grant or tuition reduction
- Laptop, Lab Fee and Meter Fee coverage

RELOCATION GRANT DISTRIBUTION OF FUNDS

Eligible Program(s):	Grant Distribution Amount:
Automotive Technology (all variations) Diesel Technology Automotive & Diesel Technology	\$1,500 orientation distribution + \$450 rent support for first three (3) months.
Airframe & Powerplant Technician	\$1,000 orientation distribution + \$450 rent support for first three (3) months.
HVACR Technician	\$1,000 orientation distribution

Rent payments will be provided within the last week of the month for the upcoming month's rent for non-shared housing students.
