Unlike a loan, a grant does not have to be repaid. The Institutional Grant and Relocation Grant are designed to assist students who have the greatest financial need. The grant amount is based on financial need. The maximum can change each award year and depends on program funding.

This grant is to assist students who are in the greatest financial need and are relocating or commuting 50 miles or greater to attend UTI by reducing their overall tuition. The grant allows students to focus on academics and gaining local employment, helping set them up for long-term success.
