# **BOBCAT® COMPACTION EQUIPMENT WARRANTY**

Bobcat Company warrants to its authorized dealers and authorized dealers of Bobcat Equipment Ltd., who in turn warrant to the owner, that each new Bobcat Compaction Equipment will be free from proven defects in material and workmanship with respect to all components of the product except as otherwise specified herein for a period of twenty-four (24) months of retail date. Retail Date is the date the product enters the commercial marketplace, as evidence by the date submitted to Bobcat Company by its authorized dealers.

During the warranty period, the authorized Bobcat dealer shall repair or replace, at Bobcat Company's option, without charge for parts and labor, any part of the Bobcat product except as otherwise specified herein which fails because of defects in material or workmanship. The owner shall provide the authorized Bobcat dealer with prompt written notice of the defect and allow reasonable time for repair or replacement. Bobcat Company may, at its option, require failed parts to be returned to the factory. Travel time of mechanics and transportation of the Bobcat product to the authorized Bobcat dealer for warranty work are the responsibility of the owner. The remedies provided in this warranty are exclusive.

## WHAT IS NOT COVERED

This limited warranty does not cover any Bobcat Compaction Equipment, part or accessory that has been subject to misuse, abuse, neglect, negligence or accident, or that has not been operated or maintained in accordance with the operating or maintenance instructions specified in the Operation and Maintenance Manual. This exclusion includes, without limitation parts or equipment that has been altered or modified so as to adversely affect its operation, performance or durability, or that has been altered or modified in ways not approved by Bobcat Company. In addition, this warranty does not cover repairs made necessary by normal wear and tear, lack of proper protection during storage or normal maintenance parts and service, including, without limitation, such things as routine cleaning, adjusting or replacing filters, spark plugs, carburetors, ignition, light bulbs, fuses, starter drive or other drive belts, brakes, clutch linings or starter brushes, or by the use of parts, supplies or accessories, including, without limitation, gasoline/diesel, oil or lubricants, which in the reasonable judgment of Bobcat Company are either incompatible with the product, adversely affect its operation, performance or durability or are other than as recommended in the Operation and Maintenance Manual or other operational instructions provided by Bobcat Company.

### **WARRANTY EXPECTATIONS**

- Service parts and un-serialized accessories are warranted for a period of 12 months from the date of purchase.
- Bobcat Company makes no warranty with respect to the engine and its service parts. Consult the Engine
  Operation Manual for the engine provided with your product or ask an authorized dealer for the terms and
  conditions of these warranties.

## LIMITATION OF IMPLIED WARRANTIES AND OTHER REMEDIES

To the extent permitted by law, neither Bobcat Company nor any company affiliated with it makes any warranties, representations or promises as to the quality, performance, or freedom from defect of the Bobcat Compaction Equipment, part or accessorycovered by this limited warranty.

THE AUTHORIZED DEALER MAKES NO WARRANTY OF ITS OWN AND SUCH DEALER HAS NO AUTHORITY TO MAKE ANY REPRESENTATION, WARRANTY OR PROMISE ON BEHALF OF BOBCAT COMPANY OR TO MODIFY THE TERMS OR LIMITATIONS OF THIS LIMITED WARRANTY IN ANY WAY

THIS WARRANTY IS EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES AND CONDITIONS, EXCEPT THE WARRANTY OF TITLE. BOBCAT COMPANY DISCLAIMS ALL OTHER WARRANTIES AND CONDITIONS, EXPRESS OR IMPLIED, INCLUDING ANY IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. IN NO EVENT SHALL BOBCAT COMPANY OR THE AUTHORIZED BOBCAT DEALER BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT OR CONSEQUENTIAL DAMAGES WHATSOEVER, INCLUDING, BUT NOT LIMITED TO, LOSS OR INTERRUPTION OF BUSINESS, LOST PROFITS, OR LOSS OF MACHINE USE, WHETHER BASED IN CONTRACT WARRANTY, TORT, NEGLIGENCE, STRICT LIABILITY, STATUTE OR OTHERWISE, EVEN IF BOBCAT COMPANY OR THE AUTHORIZED DEALER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. #### **OBTAINING WARRANTY SERVICE**

To make a claim under warranty, return the Bobcat Compaction Equipment or accessory to an authorized dealer during the

warranty term. Proof of purchase will be required to substantiate any warranty claim. Falsification of the hour meter on the Bobcat Compaction Equipment (where applicable) for verification of suspected hour meter tampering. Bobcat Company also reserves the right to final determination of hour meter tampering. Tampering of the hour meter nullifies this warranty. This warranty is effective only with the Bobcat Compaction Equipment listed herein as well as parts and accessories.
