
BOBCAT® ATTACHMENT WARRANTY

Doosan Bobcat North America, Inc. and Doosan Bobcat Canada Ltd. (collectively, “Bobcat Company”) warrant to its authorized dealers, who in turn warrant to the owner, that each new Bobcat Company Attachment (the “Product”) will be free from proven defects in material and workmanship during the applicable warranty term as defined below.

WHAT IS COVERED

This limited warranty covers defects in materials and workmanship of the Product for the Warranty Period as defined below.

WHAT IS NOT COVERED

This limited warranty does not cover the failure of any Product, part, component or accessory due to misuse, abuse, neglect, negligence or accident, alteration or modification not approved by Bobcat Company, the use of parts, supplies or accessories (including but not limited to oil or lubricants) which are either incompatible with the Product or adversely affect its operation, performance or durability, or operation, servicing or maintenance not in accordance with the operating or maintenance instructions specified in the Operation and Maintenance Manual. Further, this warranty does not cover failure due to (i) normal wear and tear, (ii) repairs made necessary by lack of proper protection during storage; or (iii) normal maintenance parts and service, including, without limitation, such things as routine cleaning or adjustments. This warranty also does not cover service parts and accessories that have not been approved and tested by Bobcat Company.

LIMITATION OF IMPLIED WARRANTIES

THE AUTHORIZED DEALER MAKES NO WARRANTY OF ITS OWN AND SUCH AUTHORIZED DEALER HAS NO AUTHORITY TO MAKE ANY REPRESENTATION, WARRANTY OR PROMISE ON BEHALF OF BOBCAT COMPANY OR TO MODIFY THE TERMS OR LIMITATIONS OF THIS LIMITED WARRANTY IN ANY WAY

THIS WARRANTY IS THE EXCLUSIVE EXPRESS WARRANTY ON THE PRODUCT, AND ANY IMPLIED WARRANTY, INCLUDING ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ARE LIMITED TO THE DURATION OF THIS WARRANTY. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above exclusion may not apply to you. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

WARRANTY TERMS

- All components of the Product, except as otherwise specified herein, are warranted for twenty-four (24) months.
- Auxiliary hydraulic quick couplers for six (6) months or 200 hours, whichever occurs first.
- Non-serialized attachments for twelve (12) months
- The foregoing time period shall commence upon delivery by the authorized Bobcat dealer to the original buyer.

REMEDIES

During the warranty period, the authorized dealer shall repair or replace, at Bobcat Company's option, without charge for parts and labor, any part of the Product, except as otherwise specified herein, which fails because of defects in material or workmanship. The owner shall provide the authorized dealer with prompt written notice of the defect and allow reasonable time for repair or replacement. Bobcat Company may, at its option, require failed parts to be returned to the factory. Travel time of mechanics and transportation of the Product to the authorized dealer for warranty work are the responsibility of the owner. The remedies provided in this warranty are exclusive.

IN NO EVENT SHALL BOBCAT COMPANY OR THE AUTHORIZED DEALER BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT OR CONSEQUENTIAL DAMAGES WHATSOEVER, INCLUDING, BUT NOT LIMITED TO, LOSS OR INTERRUPTION OF BUSINESS, LOST PROFITS, OR LOSS OF MACHINE USE, WHETHER BASED IN CONTRACT WARRANTY, TORT, NEGLIGENCE, STRICT LIABILITY, STATUTE OR OTHERWISE, EVEN IF BOBCAT COMPANY OR THE AUTHORIZED DEALER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. THE TOTAL LIABILITY OF BOBCAT COMPANY AND THE AUTHORIZED DEALER WITH RESPECT TO THE PRODUCT AND SERVICES FURNISHED HEREUNDER SHALL NOT EXCEED THE PURCHASE PRICE OF THE PRODUCT UPON WHICH SUCH LIABILITY IS BASED.

OBTAINING WARRANTY SERVICE

To make a claim under warranty, return the Product or accessory to an authorized dealer during the warranty term.
