BOBCAT® BACKHOE LOADER WARRANTY

Doosan Bobcat North America, Inc. and Doosan Bobcat Canada Ltd. (collectively, "Bobcat Company") warrant to its authorized dealers, who in turn warrant to the owner, that each new Bobcat Company Backhoe Loader (the "Bobcat Backhoe Loader") will be free from proven defects in material and workmanship during the applicable warranty term as defined below.

WHAT IS COVERED

This limited warranty covers defects in materials and workmanship of the Bobcat Backhoe Loader (the "product") for the Warranty Period as defined below.

WHAT IS NOT COVERED

This limited warranty does not cover the failure of any Bobcat Backhoe Loader, or any part, component or accessory due to misuse, abuse, neglect, negligence or accident, alteration or modification not approved by Bobcat Company, the use of parts, supplies or accessories (including but not limited to gasoline, oil or lubricants) which are either incompatible with the Product or adversely affect its operation, performance or durability, or operation, servicing or maintenance not in accordance with the operating or maintenance instructions specified in the Operation and Maintenance Manual. Further, this warranty does not cover failure due to (i) normal wear and tear, such as on bucket teeth and cutting edges; (ii) repairs made necessary by lack of proper protection during storage; or (iii) normal maintenance parts and service, including, without limitation, such things as routine cleaning, adjusting or replacing filters, spark plugs, carburetors, ignition, light bulbs, fuses, starter drive or other drive belts, brakes, clutch linings or starter brushes. This warranty also does not cover service parts and accessories that have not been approved and tested by Bobcat Company.

LIMITATION OF IMPLIED WARRANTIES

THE AUTHORIZED DEALER MAKES NO WARRANTY OF ITS OWN AND SUCH AUTHORIZED DEALER HAS NO AUTHORITY TO MAKE ANY REPRESENTATION, WARRANTY OR PROMISE ON BEHALF OF BOBCAT COMPANY OR TO MODIFY THE TERMS OR LIMITATIONS OF THIS LIMITED WARRANTY IN ANY WAY

THIS WARRANTY IS THE EXCLUSIVE EXPRESS WARRANTY ON THE BOBCAT BACKHOE LOADER, AND ANY IMPLIED WARRANTY, INCLUDING ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ARE LIMITED TO THE DURATION OF THIS WARRANTY. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above exclusion may not apply to you. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

WARRANTY TERMS

- All components of the Bobcat Backhoe Loader, except as otherwise specified herein, are warranted for twenty-four (24) months, or a total of 2000 hours of use, whichever occurs first.
- Bobcat-brand tires, are warranted for twelve (12) months, on a prorated basis based on the remaining depth of the tire at the time any defect is discovered.
- Bobcat-brand batteries are warranted for an initial twelve (12) month warranty period and for an additional twelve (12) months thereafter. Bobcat Company shall reimburse a fixed portion of the cost of replacing the battery as designated by Bobcat in the event of a proven defect.
- Auxiliary hydraulic guick couplers are warranted for six (6) months or 200 hours of use, whichever occurs first.
- The foregoing time periods shall all commence upon delivery by the authorized Bobcat dealer to the original buyer.

REMEDIES

During the warranty period, the authorized dealer shall repair or replace, at Bobcat Company's option, without charge for parts and labor, any part of the Bobcat Backhoe Loader, except as otherwise specified herein, which fails because of defects in material or workmanship. The owner shall provide the authorized dealer with prompt written notice of the defect and allow reasonable time for repair or replacement. Bobcat Company may, at its option, require failed parts to be returned to the factory. Travel time of mechanics and transportation of the Bobcat Backhoe Loader to the authorized dealer for warranty work are the responsibility of the owner. The remedies provided in this warranty are exclusive.

IN NO EVENT SHALL BOBCAT COMPANY OR THE AUTHORIZED DEALER BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT OR CONSEQUENTIAL DAMAGES WHATSOEVER, INCLUDING, BUT NOT LIMITED TO, LOSS OR INTERRUPTION OF BUSINESS, LOST PROFITS, OR LOSS OF MACHINE USE, WHETHER BASED IN CONTRACT WARRANTY, TORT, NEGLIGENCE, STRICT LIABILITY, STATUTE OR OTHERWISE, EVEN IF BOBCAT COMPANY OR THE AUTHORIZED DEALER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. THE TOTAL LIABILITY OF BOBCAT COMPANY AND THE AUTHORIZED DEALER WITH RESPECT TO THE PRODUCT AND SERVICES FURNISHED HEREUNDER SHALL NOT EXCEED THE PURCHASE PRICE OF THE PRODUCT UPON WHICH SUCH LIABILITY IS BASED.

OBTAINING WARRANTY SERVICE

To make a claim under warranty, return the Bobcat Backhoe Loader or accessory to an authorized dealer during the warranty term.

Proof of purchase will be required to substantiate any warranty claim. Tampering of the hour meter nullifies this warranty. This warranty is effective only with the Bobcat Backhoe Loader listed herein as well as authorized parts and accessories.
