
BOBCAT® ELECTRIC LOADER LIMITED WARRANTY

Doosan Bobcat North America, Inc., doing business as Bobcat Company warrants to its authorized dealers, who in turn warrant to the owner, that each new Bobcat Company Electric Loader will be free from proven defects in material and workmanship during the applicable warranty term.

WHAT IS COVERED

This limited warranty covers defects in materials and workmanship of the Bobcat Company Electric Loader, (the "Product") for the Warranty Period as defined below.

WHAT IS NOT COVERED

This limited warranty does not cover the failure of any Product, part, attachment or accessory that has been subject to misuse, abuse, neglect, negligence or accident, alteration or modification not approved by Bobcat Company, the use of parts, supplies or accessories which are either incompatible with the product or adversely affect its operation, performance or durability, or operation, servicing or maintenance not in accordance with the operating or maintenance instructions specified in the Operation and Maintenance Manual. Further, this warranty does not cover failure due to (i) normal wear and tear; (ii) corrosion due to spreading, carrying or applying corrosive materials such as fertilizers (iii) repairs made necessary by lack of proper protection during storage (iv) defects caused by failure to follow the instructions for proper charging and maintenance procedures set forth in the documentation provided at the time of purchase; or (v) normal maintenance parts and service, including, without limitation, such things as tune-up parts, and other high-wear items. This warranty also does not cover service parts and accessories that have not been approved and tested by Bobcat Company.

LIMITATION OF IMPLIED WARRANTIES

THE AUTHORIZED DEALER MAKES NO WARRANTY OF ITS OWN AND SUCH AUTHORIZED DEALER HAS NO AUTHORITY TO MAKE ANY REPRESENTATION, WARRANTY OR PROMISE ON BEHALF OF BOBCAT COMPANY OR TO MODIFY THE TERMS OR LIMITATIONS OF THIS LIMITED WARRANTY IN ANY WAY.

THIS WARRANTY IS THE EXCLUSIVE EXPRESS WARRANTY ON THE PRODUCT, AND ANY IMPLIED, INCLUDING ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE ARE LIMITED TO THE DURATION OF THIS WARRANTY. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above exclusion may not apply to you. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

Warranty Term

- All components of the Product, except as otherwise specified herein, are warranted for twenty-four (24) months, or a total of 2000 hours of use, whichever comes first.
- Tracks for a period of twelve (12) months, on a prorated basis based on the remaining depth of the track at the time any defect is discovered.
- Bobcat branded auxiliary batteries, for an initial period of twelve (12) months; for an additional twelve (12) months thereafter, Bobcat Company shall reimburse a fixed portion of the cost of replacing the battery designated in the event of proven defect.

REMEDIES

During the warranty period, the authorized dealer shall repair or replace, at Bobcat Company's option, without charge for parts and labor, any part of the Bobcat Company Product except as otherwise specified herein which fails because of defects in material or workmanship. The owner shall provide the authorized dealer with prompt written notice of the defect and allow reasonable time for repair or replacement. Bobcat Company may, at its option, require failed parts to be returned to the factory. Travel time of mechanics and transportation of the Bobcat Company product to the authorized Bobcat dealer for warranty work are the responsibility of the owner. Remedies provided in this warranty are exclusive.

IN NO EVENT SHALL BOBCAT COMPANY OR THE AUTHORIZED DEALER BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT OR CONSEQUENTIAL DAMAGES WHATSOEVER, INCLUDING, BUT NOT LIMITED TO, LOSS OR INTERRUPTION OF BUSINESS, LOST PROFITS, OR LOSS OF MACHINE USE, WHETHER BASED IN CONTRACT WARRANTY, TORT, NEGLIGENCE, STRICT LIABILITY, STATUTE OR OTHERWISE, EVEN IF BOBCAT COMPANY OR THE AUTHORIZED DEALER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. THE TOTAL LIABILITY OF BOBCAT COMPANY AND THE AUTHORIZED DEALER WITH RESPECT TO THE PRODUCT AND SERVICES FURNISHED HEREUNDER SHALL NOT EXCEED THE PURCHASE PRICE OF THE PRODUCT UPON WHICH SUCH LIABILITY IS BASED.

OBTAINING WARRANTY SERVICE

To make a claim under warranty, return the Bobcat Company Product, part, attachment, or accessory to an authorized dealer during the warranty term.

Proof of purchase will be required to substantiate any warranty claim. Tampering of the hour meter nullifies this warranty. Falsification of warranty documentation nullifies this warranty.
