Happy Holidays and a Most Happy New Year!

We hope to inspire you to give to one or more of the amazing charities and nonprofit organizations included in the 2019 Charitable Gift Guide. In 2019 we not only doubled the size of the Gift Guide, but introduced centralized online giving for any of the charities. You are encouraged to visit the Blue Mountain Community Foundation website, www.bluemountainfoundation.org/catalog, for the online Giving Catalog.

The Giving Catalog consists of three things co-sponsored by both BMCF and the Sustainable Living Center: 1) The Charitable Gift Guide newspaper insert, 2) an online giving portal (www.bluemountainfoundation.org/catalog) and 3) The Alternative Gift Fair, a festive day-long Fair on Saturday, December 7th at Reid Center at Whitman College, from 11 to 3.

The Charitable Gift Guide sought to be as inclusive as possible and invited any qualified 501 c 3 organization in the area to participate. But you will be impressed and inspired. The website, logo, charitable tax ID # and profile describing each charity's work are featured.

The Giving Catalog has taken these profiles and shared them online at www.bluemountainfoundation.org/catalog. The giving portal will be active through the end of Tuesday, December 31st at 11:59 p.m. See p. 3 to learn more about "Giving Online."

To encourage giving and a little friendly competition in fund-raising and friend-raising, BMCF will award three grants of \$1,000 each to the charities that succeed in raising the most money, receives the largest single donation or receives donations from the most people (this is not the most donations – it is the most donors!). There will be a few smaller pop-up prizes available to charities as well during December.

BMCF was founded in 1984 to seek gifts from many people for the purpose of supporting many charities in perpetuity. Since then generous people have created endowments at BMCF of over \$51 million. In 2018, \$2.8 million was donated in grants and scholarships to a wide variety of organizations and causes, and to hundreds of students.

If you are a newcomer to the Walla Walla Valley you might also read the Charitable Gift Guide for information on the types of charitable organizations in the Valley. There are many opportunities to get involved in ways that make a difference. As a volunteer or a donor you will be welcomed by these community-minded organizations.

Even with this extensive list of charities, however, the need outstrips current resources. Please be generous.

Walla Walla Alternative Gift Fair

The Walla Walla Alternative Gift Fair is an event that brings together nonprofit organizations from around our Valley to speak with visitors about the services they provide. As an alternative to traditional gifts, usually an item purchased in a store, participating nonprofits offer 'gifts' of support to be given in the name of the special people in one's life. Gifts range in price from \$5 to \$100 or can be made for any custom amount. Fairgoers can select gifts from any or all of the thirty-one participating organizations and make just one payment at checkout.

The Fair also features the live festive sounds of local musicians Glenn Morrison & Jimmye Turner, who volunteer their time and talent in support of the Gift Fair effort! Complimentary hot beverages and a free 'make-a-gift' craft table round out the activities. Visitors can also purchase treats from the bake sale and tickets for a raffle of items donated by the participating nonprofits. Gift cards describing the gift and organization to present to the recipient will be available.

The Sustainable Living Center first became involved with the gift fair concept as a participant in an alternative gift fair as part of the Alliance for a Sustainable and Livable Community. Through the support of the SLC Board and in partnership with WWCC and fifteen adventurous community partners, the first AGF in Walla Walla took place in 2015. The event was a success with lots of enthusiasm from both participants and visitors. The opportunity for organizations to engage with community members face to face, for organizations to make and reinforce connections with their nonprofit peers, and for the community to have additional options for giving during the holidays, seemed to resonate with participants.

Since 2015, the annual fair has grown in size and scope. In 2019, the AGF will serve as the physical kick-off for the Blue Mountain Community Foundation's first-ever Blue Mountain Giving Catalog. This virtual giving platform highlights sixty Valley non-profits, thirty-one of whom are also participating in the AGF, and runs for the whole month of December. Each organization has a fundraising goal for the catalog and all gifts of support made at the AGF will go towards reaching the goal amount. Our mission is to 'conserve resources for the future by encouraging and facilitating sustainable living practices in our community'. We believe the AGF will help our community move toward sustainability in giving. \$250,000 is awarded through this annual competitive process which is less than 10% of the total \$2.8 million in grants and scholarships BMCF made last year. This year we were not able to support excellent programs for purposes ranging from helping homeless people to expanding culture and the arts to preserving the environment. The source of these Discretionary Grants within BMCF are far-sighted donors who created permanent funds to help the community forever, and who have left the actual selection of future grants to BMCF's all-volunteer committee. Knowing that 20, 30 or 40 years from now the problems facing our Valley will probably be different from those we face today, these donors trust that future leaders are best suited to decide how these funds are used to solve problems. Program development and expansion. As a small non-profit Camp Fire has a BIG impact. Camp Fire would like to continue the impact like they have since 1924 when Camp Fire was established in the Walla Walla and College Place communities. The history and impact Camp Fire has had in this community is like no other. There are women that were involved in Camp Fire Girls before Camp Fire became Camp Fire Boys and Girls in 1975 that have fond memories of Camp Fire and learned much of their strength and independence by being involved with this guiding organization. There are women in their 80's and older that are still in this area and are donating their beloved ceremonial gowns and beads along with their Camp Fire books and journals. They learned and lived by Wo-He-Lo (Work, Health, Love). Currently Camp Fire serves youth in the area by providing them with a safe place to be when they are not able to be with their families. Activities such as homework help, physical activity, healthy snacks and creative activities that create sparks in children are implemented Monday through Friday during the school year and non-school days. Summer at Camp Fire provides children with friendships, team building, new games, gardening, swimming, leadership, outdoor living skills and most of all prevention of summer learning loss. School aged children are important and do need a place to go, Camp Fire is happy to provide scholarships for families that cannot afford the full cost of programs.

The mission of Carnegie Picture Lab is to nourish creativity by supporting and enhancing arts education for elementary school children in the Walla Walla Valley. The program partners with school districts, educators, parents, artists, volunteers and the community to develop and present a robust arts educa-

tion curriculum in the schools. Carnegie Picture Lab is currently in 12 schools in Washington and Oregon, reaching over 4,000 elementary schoolchildren with the help of 60 volunteers. Picture Lab provides over 1,000 hours of classroom art instruction, the only dedicated arts instruction most of these children receive. In addition to the classroom program, Picture Lab works with community partners such as the Public Library and the Walla Walla Symphony to provide public arts education programs to the larger Walla Walla community.

In our school-based Picture Lab program, volunteers enter K-5 classrooms to provide art history and art creation lessons to children. Children learn about three artists each year; volunteers present the art history portion of the curriculum through PowerPoint presentations and art posters and then children work on hands-on art projects related to the artists they just learned about. In 2019-20, students will learn about Frida Kahlo, Piet Mondrian and Photography, and each school library will receive books on the featured artists. Picture Lab provides all the art supplies necessary to enable the children to work with superior art supplies and in multiple art media. The Giving Catalog will fund needed materials and supplies for Picture Lab lessons.

Funds received from our generous donors help us continue to run programs such as mental health counseling, The LOFT youth shelter and our fuel assistance program. Donations received allow for the Counseling Program to continue providing mental health services to children, youth, adults and families by subsidizing counseling appointments and purchasing books to facilitate personal growth and materials needed for play therapy. The LOFT provides short term shelter and helps to secure permanent stable housing to youth ages 12-17 experiencing homelessness. Funds received from our donors help our LOFT staff provide healthy meals, clean clothes and hygiene products for the youth residing there. Providing these basic needs is essential to insure our youth feel valued. Additionally, donations may also be used to cover the cost of other youth needs, such as obtaining their state IDs, backpacks and school supplies in order to continue their education during the time they are in our care or supporting the engagement in community and healthy social events. Activities might include attending the YMCA for recreational purposes, the county fair, city pool or the local movie theatre. Donations allow Catholic Charities to

Unlike many other nonprofits, we take no government money and are funded entirely by the generous donations of people like you.

Experts in the field present to the study group, composed of diverse residents from the community. The group notes significant findings, which they use to develop conclusions and recommendations. Building on that, the two to three year advocacy phase brings residents together with business, government, and nonprofit leaders throughout the region to implement those community-developed recommendations.

Please help DCBF continue working to accomplish goals in 4 different programming areas:

- 1. Supporting the Danza Classica Ballet Company - a group of local, youth ballet dancers selected by audition with standards of performance. Support for the Company includes raising funds to pay for choreography, guest teachers, and providing performance opportunities. Our volunteer Artistic Director is Ms. Idalee Hutson-Fish.
- Scholarships: to assist with ballet class tuition, ballet shoes and apparel, or summer dance intensives. Since 2017, DCBF has given 19 students tuition assistance scholarships (\$2,567), 2 students financial aid for ballet shoes and apparel (\$379), and helped 9 dancers with summer intensive fees (\$4,060).
- 3. Ballet Education: Over the past 5 years, DCBF has underwritten expenses to bring 7 different ballet professionals to WW to teach free/reduced fee Masterclasses to area ballet students. Student dancers have come from Walla Walla, Pendleton, Moses Lake and Lewiston

to participate. DCBF has also underwritten the training costs for local dancers to participate live, on-stage with the Eugene Ballet Company when they have come to perform The Nutcracker with the WW Symphony (2016 and 2018).

4. Outreach: Underwriting local ballet productions at least twice annually; providing free children's tickets to performances; offering ballet exhibitions at community events or wineries.

We have partnered with the Walla Walla Chamber Music Festival for collaboration to demonstrate the creative process of performing ballet with live music. An open rehearsal and a performance were given this past June.

Dayton Historical Depot Society's mission is to preserve Columbia County's history and to use our artifacts for the interpretation of that history. We strive to educate our community members about the heritage of Dayton and the surrounding area. Our exhibits are our primary method of accomplishing these goals and many resources must be expended to prepare the artifacts, particularly the photographs, for viewing. Presently, our Photographic Archive consists of over 4000 photographs of Dayton and Columbia County.

Unfortunately, only about 10% of these photos have high resolution negatives which are necessary for the creation of exhibit quality prints. Without these negatives, the photos cannot be easily used in our exhibits, so their value cannot be fully appreciated by our visitors. Providing Archival Support will help us expand the collection of high resolution negatives, and it will also assist us in the preservation of Columbia County's stories through our newsletters and video histories. An exhibit must also provide historical and cultural context for the artifacts the visitor is viewing. This context is provided by well-researched and concisely written storyboards that are used throughout the exhibits. Archival Support will help us to continue our mission and to develop professional quality exhibits that are enjoyed by approximately 2500 visitors each year.



Early Life Speech & Language

ELSL provides intensive, individualized therapy to children ages 2-7 that are struggling with speech and language delays. This therapy is provided at no cost to the families. Our goal is to ensure all children will have the verbal communication skills needed for success at home, in school and in life. The ELSL Walla Walla clinic was opened in April 2017 to meet the needs of the underserved children of the Walla Walla Valley. With a full caseload of children receiving therapy and a list of children waiting in line, the need for these services is well demonstrated.

The Walla Walla ELSL clinic is housed in the Masonic Center in Walla Walla. Families learn about the clinic through referrals from other parents, pediatric physicians, teachers and friends. Each child is assessed by the therapist and a treatment plan is developed specifically for that child. Therapy consists of individualized sessions including the child and parent working with the therapist. The parent is trained on how to help the child practice between therapy sessions. Once treatment begins, the child is assessed every three months to measure progress and refine the child's therapy needs.

Our job is to connect people struggling to meet basic needs with the community resources needed to achieve stability. Trained, caring staff and volunteers meet with clients to assess needs and screen for eligibility of available local resources. We provide direct assistance with a variety of essential needs, and when appropriate make referrals to a wide network of local social service agencies.

Who we serve: In 2018 Helpline provided 19,449 cases of service to 2,247 separate households made up of 5,001 individuals, including 1,615 children, 537 single parents, 275 veteran and 540 homeless "households".

Local churches and other community groups also rely on us to screen for needs. This allows them to focus on their own missions knowing that knowledgeable, caring Helpline staff and volunteers will assess the situation, connect those in need with available resources, and make sure that funds are wisely spent.

In a nutshell – Helpline's coordinated screening and referral process connects our most vulnerable residents with the resources they need in a cohesive manner, prevents duplication of services, maximizes the use of limited community resources, identifies gaps in services, and increases donor confidence that real needs are met.

Current equipment is reaching its end of life and downtime for repairs has started to impact our program operations. Lillie Rice Center is looking to purchase an identical model of mower for a backup unit to ensure smooth continued operations in the event current equipment is down for repairs. In addition, a leaf catcher and snow blower attachment is needed for our currently utilized 1445 John Deere Mower.

In order to expand our services (and in turn provide additional employment opportunities for individuals with disabilities) upgrading our equipment would provide a less laborious and more efficient method of:

A. Leaf Season Clean up: Standard current operations removal is done manually using a leaf rake. If it's a windy and/or rainy day, this makes it physically demanding as raking can become very difficult. It is necessary for participants to take regular and extended breaks, as the vigorous exercise tires individuals out quickly. It also limits the individuals that are able to perform the task.

B. Snow removal: During times of heavy snow, removal is done using a small walk behind snow blower. When doing large areas such as parking lots, the task is time consuming as the current equipment only allows a small portion of the area to be completed at a time. With a snow blower attachment, participants would be able to complete large tasks more efficiently and would open up other contract opportunities.

Children learn tools for expressing their emotions in ways that are not harmful to themselves or others. Camp activities include games, crafts, swimming, fishing, and time for sharing and learning in group activities. The camper/counselor ratio is 1:1. Up to 30 children may participate in Camp Amanda.

The 2019 budget for Camp was \$23,750 and we are very dependent on grants and donations. For 2020, we anticipate an investment of \$3,000 in kitchen supplies, craft supplies, stuffed Pandas (our mascot) and other miscellaneous supplies. We also expect to invest upwards of \$2,000 for food to feed 30 campers and upwards of 40 volunteers.

YWCA Walla Walla's signature program is the Domestic Violence and Sexual Assault Resource Center: a domestic violence shelter, counseling, support groups, advocacy, information and more. We offer quality, licensed childcare programs for ages 1 through 12, domestic violence and sexual assault prevention programs in area schools, and a number of community and personal enrichment programs.

Walla Walla and the Blue Mountain region are fortunate to be the home of several significant grantmakers - charitable trusts, foundations and businesses. Among them is the Blue Mountain Community Foundation, created in 1984 from scratch. Since then BMCF's assets have increased to \$51 million due to the generosity of our community. Last year the Community Foundation gave \$2.8 million, bringing our total grants and scholarships paid since inception to \$36 million.

- Grants in 2018 were \$2 million and were paid to 197 charities and public agencies
- \$748,500 in scholarships were paid on behalf of 332 students last year
- Total number of funds at BMCF grew to 348
- 60 families have included BMCF in their will or estate plan for a future gift

HOW IS THE COMMUNITY FOUNDATION DIFFERENT AS A CHARITY?

There are over 750 community foundations in the U.S.; 25 in the State of Washington. Most have a primary geographic service area. BMCF's primary service area is Walla Walla, Columbia, Garfield and Umatilla counties.

How is a Community Foundation different from most other charities? Community foundations ...

- ...are intended to exist in perpetuity to serve their communities.
- ... are to seek funds from many people, and to make grants to many different charities for a wide variety of purposes. Most of BMCF funds specifically benefit another charity.
- ... support the direct services of other charities rather than offering programs themselves.
- ...help other charities by managing and investing their endowments.
- ...fund their operations by assessing modest annual administrative fees of their endowment funds – at BMCF these are generally 1% or less, among the lowest in the Pacific Northwest. This means the Community Foundation is stable and sustainable.
- ...offer donors flexibility and guidance in philanthropy. BMCF has seven fund types at least one of which will be the right fit for any donor.
- ...may own and manage real estate especially agricultural land for charitable purposes. For example, BMCF ensures the donor's wishes that the proceeds of the Lamar Farm support scholarships
- ...provide a range of financial services for charitable purposes such as fiscal sponsorships, pass-through gifts and grantmaking services.
