Introductions and Call to order - Pamala

o The meeting was called to Order by CAC Chair, Pamala Dame at 12:05 p.m.

Den Score – Kyle (30 minutes)

- O DenScore was created for community members so people can make informed decisions. It is to be used as an education and awareness tool for the community. The app allows members to manage decisions and options, like going to the ER, finding a high-quality dentist, or figuring out many other issues like insurance. The DenScore app focuses on patients that do not have a dental home. Although the app has yet to be made live, it will be released as an app-based application in two weeks. That will be a targeted ad campaign that can provide a resource and mobile option for dental services.
- DenScore hopes to partner with Coordinated Care Organizations (CCO) to integrate the app into many different applications, including telehealth. A member-centric tool to offer solutions to serve stakeholders and members with the end user in mind to provide patient-centered care.
- The DenScore app is a concept app that Cascade Health Alliance (CHA) is looking to see the possibility of benefiting members. So, to determine if the app will benefit members, CHA

brings it to the CAC to receive insight on if they would not only use the app but if it is a helpful tool. Ultimately, the CAC determined the DenScore app would not be useful or utilized by CHA members. For details on why, contact the CHA CAC Coordinator.

OHA Leadership Changes

O There were some leadership changes at Oregon Health Authority (OHA); Director Pat Allen's last day was January 3. 2023. Also, Kris Kautz, COO, will be Interim Director until Tina Kotek's appointee James Schroeder is present effective on January 10, 2023. The Behavioral Health Director is stepping down in January, and Bessie Scott will be the new Behavioral Health Director. Lastly, government relations director Jeff Scroggins's last day was December 16, 2022, as Ashley Thirstrup became Interim Government Relations.

COVID-19 Boosters for Children

O Children who need the booster from six months to four years old are eligible. The COVID-19 vaccine is safe and effective, and if you have any questions, talk with your health provider for more information. Due to physician transfers, the Stanford Clinic still needs to re-register for COVID-19 shots. Gram Pediatric Clinic is in the process of enrolling, but Klamath Open Door, Sky Lakes, and Public Health are offering the vaccination.

o Seeking care for RSV in Children

o It is recommended to seek care for your child if they have one or more severe symptoms of Respiratory Syncytial Virus (RSV). Like difficulty breathing, increased work of breathing, less than one wet diaper every eight hours, a noticeable gray or bluish tint to the tongue and lips or skin or decreased activity and alertness.

Open Enrollment for Private Health Insurance

The last day for enrollment for private health care was January 15, 2023. For Oregon's health insurance marketplace, Open enrollment is the only time when anyone who has not been offered insurance from a job or a public program like Oregon Health Plan or Medicare. They can enroll in health coverage through Oregon Health Care.gov, often with financial help. Both are quick and easy-to-use window-shopping tools (https://orhim.info/shop) and can determine affordable job-based coverage (https://orhim.info/ESItool) where users can see available plans and savings. Also, it allows users to see programs for prescription drugs and networked primary care doctors or hospitals, and gov/gethelp's health insurance experts provide free local services. So, it is encouraged that all Oregonians who do not currently have health insurance available to start at OregonHealthCare.gov.

Community Conversation about Applied Behavior Analysis

OHA is seeking community feedback on Applied Behavior Analysis (ABA). ABA is a therapy-based treatment for those diagnosed with autism and has Oregon Health Plan (OHP) benefits. The current administrative rules cover Medicaid payments and providers but do not cover oversight or management of ABA programs or facilities. Please join the community conversations to review existing laws and regulations.

o New OHP Benefits in 2023

Effective on January 1, 2023, the Oregon Health Authority (OHA) and CCOs are required to cover any medically necessary and medically appropriate service for Oregon Health Plan-enrolled children and youth until their 21st birthday. Under the federal Early Periodic Screening, Diagnosis, and Treatment (EPSDT) benefit regardless of the priority list. Additionally, approval to raise the Birth Doula to \$1,500 gives members more opportunity and time. Also, the veteran dental program has specific criteria for first come, first serve, and veterans can sign-up through OHA.


COVID-19 boosters for children



When to seek care for RSV in children



Open enrollment for private health insurance:

- Jan. 15 is the last day of open enrollment for private health insurance in Oregon's health insurance marketplace. Open enrollment is the only time when anyone who are not offered insurance from a job or a public program like the Oregon Health Plan or Medicare can enroll in health coverage through <u>OregonHealthCare.gov</u>, often with financial help.
- This is a quick and easy-to-use <u>window-shopping tool</u> (<u>https://orhim.info/shop</u>) where users can preview which plans and savings are available to them. The tool also allows users to see which plans cover their prescription drugs and are networked with their preferred primary care doctor or preferred hospitals.
- A <u>new tool</u> (<u>https://orhim.info/ESItool</u>) can help you figure out if job-based coverage is considered affordable.
- Free local help can be found from health insurance experts around the state at gov/GetHelp.
- Bottom line: we encourage all Oregonians who do not currently have health insurance available to start at <u>OregonHealthCare.gov</u>.

New OHP benefits in 2023

- Effective January 1, 2023, the Oregon Health Authority (OHA) and coordinated care organizations (CCOs) are required to cover any medically necessary and medically appropriate service for OHP-enrolled children and youth until their 21st birthday, regardless of the Prioritized List, under the federal Early Periodic Screening, Diagnostic and Treatment (EPSDT) benefit. Here is what this means for members: Member Fact Sheet.
- Oregon received approval from CMS to raise Birth Doula rates from \$350 up to \$1500 retroactive to July 1st, 2022. Awaiting rates to be loaded to MMIS—communication notice coming soon.
- Veteran's dental program and CCOF dental, January 1st 2023. How to apply for Veteran's dental program flyer <u>HERE</u>
