## Annual Celebration Basket Raffle Week Rescheduled for October 5 - 9

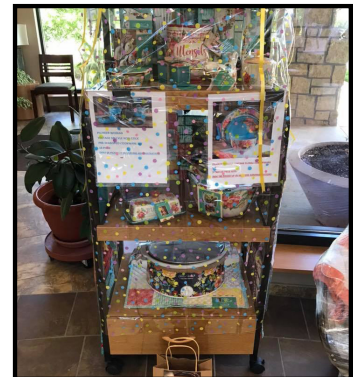
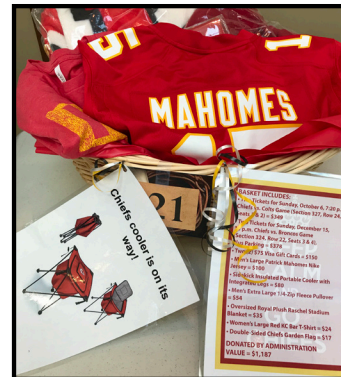
Cass Regional will host the Celebration Basket Raffle October 5-9, in the Cass Regional Medical Center Rotunda. Tickets will be sold on site each day.

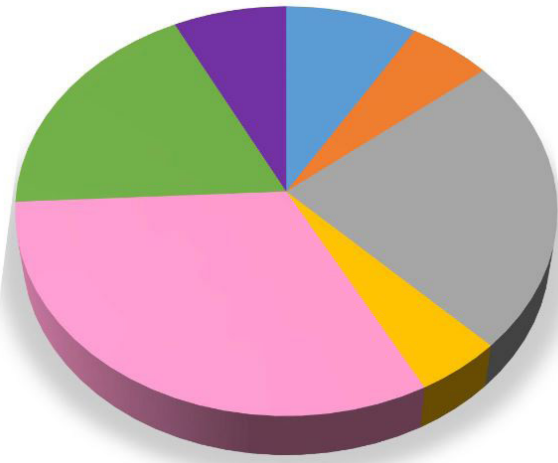
