Groundbreaking Held for Community Trail

Cass Regional Medical Center Foundation held a small groundbreaking ceremony for The Floyd and Franceline Parris Community Trail on Thursday, June 18.

Construction of the trail began the week of June 22 on eight acres behind the Cass Regional campus. When completed, the trail will have a small parking area off Healing Way, and will feature two quarter-mile loops, a gazebo, and several benches placed along the path for resting points. The trail will be paved, allowing access for those who use assistive devices such as walkers and wheelchairs. Howco Utilities of Pleasant Hill is the contractor overseeing its construction.

The trail is slated for completion in late summer/early fall. More than \$385,000 has been donated for the project. Many thanks to the Franceline Parris Trust and all the donors who have made the trail possible!



Employee Assistance Fund Provides Vital Assistance During Pandemic

The Employee Assistance Fund has helped 24 Cass Regional employees so far in 2020, many of whom have experienced a financial crisis related to the coronavirus pandemic. The amount that has been granted to date this year is \$20,800, far exceeding what is typically granted during a seven-month period.

Employees who are seeking assistance submit a brief application that explains their need, along with bills to be considered for payment on their behalf. The requests are reviewed by an elected committee of six employees, who make a determination on how much to grant based on the information provided. The bills are then paid directly to the creditors by the foundation. All requests are confidential, and the maximum that is typically awarded per request is \$750. In some cases, assistance with food and household supplies is also provided.

The fund was started 20 years ago, and for most of its history, it has been primarily funded by regular payroll installment donations from Cass Regional employees. This spring, the number of assistance requests increased significantly, and several community donors also stepped forward to help. Special thanks to everyone who reached out to support our Cass Regional staff during this challenging time. We are deeply grateful!

Annual Celebration Basket Raffle Week is October 5 - 9


