## Cass County Area COVID-19 Testing Options (Updated November 11, 2020)

#### **Rapid Testing:**

Due to the increase in cases in the Kansas City area, rapid testing is being reserved for emergency patients who are ill and require admission, emergent surgical/GI procedures, and first responders/hospital staff.

## **Cass County Health Department**:

Drive-up testing locations:

Wednesdays @ Belton Regional Medical Center, 7am-10am

Thursdays @ Cass Regional Medical Center, 7am-10am

Both are FREE to anyone who lives, works, or goes to school in Cass County. You do not have to have symptoms or an exposure to be tested. There are 150 tests available each week at each location, and you must register in advance at <a href="https://www.casscounty.com/health">https://www.casscounty.com/health</a>. If you do not have access to a computer, you can call 816-380-8425, press 0, and someone will work with you to get pre-registered. 2-4 day turnaround time (TAT).

### **Cass Regional-affiliated Clinics:**

NOTE: Testing is currently limited at these locations. You must be a current patient with a provider at one of these clinics.

Harrisonville Medical Clinic - rapid testing for those who are <u>symptomatic</u> only. Appointment required. Or HMC can set up an appointment through HFM (see hours below), referral required. 2-3 day TAT. Call 816-380-7470. Peculiar Medical Clinic - rapid testing for those who are <u>symptomatic</u> only. Appointment required. Or PMC can set up an appointment through HFM (see hours below), referral required. 2-3 day TAT. Call 816-779-1100. Garden City Medical Clinic - rapid testing for those who are <u>symptomatic</u> only. Appointment required. Or GCMC can set up an appointment through HFM (see hours below), referral required. 2-3 day TAT. Call 816-773-6203. Pleasant Hill Medical Clinic - rapid testing for those who are <u>symptomatic</u> only. Appointment required. Or PHMC can set up an appointment through HFM (see hours below), referral required. 2-3 day TAT. Call 816-540-2111.

Archie Medical Clinic - rapid testing for those who are <u>symptomatic</u> only. Appointment required. Or AMC can set up an appointment through HFM (see hours below), referral required. 2-3 day TAT. Call 816-430-5777. Kingsville Medical Clinic - rapid testing for those who are <u>symptomatic</u> only. Appointment required. Or KMC can set up an appointment through HFM (see hours below), referral required. 2-3 day TAT. Call 816-597-3500.

# **Harrisonville Family Medicine (HFM)**:

Monday - Friday, appointment and physician referral required. Times vary. 2-3 day TAT. Call 816-380-3582.

### CVS (Belton, Harrisonville and Raymore):

Drive-thru testing. Must register in advance. 2-3 day TAT.

#### Price Chopper (Harrisonville)

Drive-thru testing. Last known TAT was 2-3 days.

#### **Raymore Urgent Care**

Does testing from 12-4 p.m. on Thursdays, appointment required, 2-3 day TAT.

### **Care Now Urgent Care (Lee's Summit):**

Only doing rapid COVID testing for surgical patients (need orders), health care workers, and first responders. Must go to <u>carenow.com</u> to register for an appointment that day and they fill up quickly.
