Previous Minutes	The minutes of the 21 November 2017 meeting were approved as presented.
Phase II Disaster Recovery	Kevin Anderson presented a capital request to proceed with the purchase of Phase II for Disaster Recovery. This will include the expansion of our storage infrastructure to allow back-up of all the data. This will replace our current DR site. A motion was made, seconded and carried TO RECOMMEND TO THE CGH BOARD OF DIRECTORS THE APPROVAL TO PROCEED WITH THE PURCHASE OF THE PHASE II OF DISASTER RECOVERY AT A COST NOT TO EXCEED \$188,000.
Natus EMG/Ultrasound Unit	Wayne Davis presented a capital request to purchase a Natus EMG/Ultrasound unit. This will replace our current EMG unit that no longer has any book value. This unit will be integrated with Nextgen for more efficiency. A motion was made, seconded and carried TO RECOMMEND TO THE CGH BOARD OF DIRECTORS THE APPROVAL TO PURCHASE A NATUS EMG/ULTRASOUND UNIT AT A COST NOT TO EXCEED \$61,033.
Pathology IHC Stainer	Cheryl Baker presented a capital request to purchase a pathology IHC stainer. This will allow CGH to perform diagnostic/prognostic of suspected cancer cases. We currently send these samples out and have a turn-around time of 7-10 days. With completing these at CGH, we will decrease that turn-around time to approximately 2-3 days. A motion was made, seconded and carried TO RECOMMEND TO THE CGH BOARD OF DIRECTORS THE APPROVAL TO PURCHASE A PATHOLOGY IHC STAINER AT A COST NOT TO EXCEED \$92,500.
MERCI Radio	Cindy Zander presented a capital request to purchase a MERCI radio system. This will replace our current radio system which is 15 years old, no longer supported and has no book value. A motion was made, seconded and carried TO RECOMMEND TO THE CGH BOARD OF DIRECTORS THE APPROVAL TO PURCHASE A MERCI RADIO AT A COST NOT TO EXCEED \$51,455.
CGH Financial Statement	s Ben Schaab presented the consolidated financial statements and statistical reports for December 2017. He also presented an overview of the investments for the
