CGH Recognizes DAISY Award Winner Stacy Dillard, RN

Stacy Dillard, a registered nurse and Lead Shift Coordinator, was recently recognized as a recipient of the prestigious DAISY Award for extraordinary nurses. An international program, the award is presented to nurses around the world who go above and beyond for their patients and demonstrate extraordinary compassionate care.

"I'd like to nominate Stacy Dillard for the Daisy Award," said Kristie Geil, CGH Chief Nursing Officer. "It's my understanding that she provided outstanding poise and leadership during an extremely challenging time. People don't realize how difficult the role of Shift Coordinator can be after hours and on weekends. They are responsible for so many things and wear so many hats. Stacey wears all of them stylishly well and with great autonomy. I'm not sure what else to say to articulate how her constant leadership is deserving of this recognition, but I took her phone call at 0400 one Saturday morning. In true style, she gave her everything to the staff, the patients and the family."

The DAISY Award - an acronym for "Diseases Attacking the Immune System" - was established by the DAISY Foundation in California in memory of J. Patrick Barnes, who died at age 33 of an autoimmune disease. During his hospitalization, they deeply appreciated the care and compassion shown to Patrick and his entire family. When he died, they felt compelled to say "thank you" to nurses in a very public way. The DAISY Award continues to recognize and celebrate the outstanding professionalism and compassion that nurses bring to patients and their families every day.

Visitor/Masking Update Q & A

Beginning Monday, March 14, 2022, we will no longer screen patients at our doors for COVID symptoms. **However, per IDPH, masks are still required in healthcare facilities for patients and visitors.** Therefore, we will have masks and hand sanitizer available at the entrances. If a patient or visitor comes to you without a mask, please offer one to them.

What are the new masking guidelines for staff?

Per IDPH, masks are still required in areas of direct patient care, or areas where you may come in contact with patients or the public (hallways, cafeteria, restrooms, waiting rooms, and other public spaces).

• When patients are NOT in - or passing through - your area, masks will be optional.

Will the visitor policy or visitor hours change?

No, these will remain the same. The current **hospital** visitor policy is as follows:

- One to two patient-designated visitors at a time in rotation are allowed.
- Visitor hours are from 8 am to 8 pm. One visitor may stay overnight with the patient as requested.
- Visitors will no longer be required to wear the Visitor Screened stickers (except those who will be staying after 8 pm in the hospital, which was the process pre-COVID).
- No visitors under the age of 18 (unless approved by the Dept Manager).
- All visitors must mask when entering/exiting the premises (in the hallways, etc) and when the healthcare team is in the patient's room providing care.
- Visitors must remain in the patient room during the patient's stay or in the designated waiting area while the patient recovers.
- Special exceptions may be allowed for: Minor children admitted to the hospital, developmentally disabled patients, special circumstances (i.e. dementia, decisional capacity), outpatient testing patients who need assistance, Birthing Center, end of life

Visitor restrictions are lifted at all CGH Clinics.

When will the other entrances and our waiting rooms re-open?

The hospital's East and West doors, as well as the waiting rooms, will re-open on Monday, March 14.

When will break room restrictions be lifted?

As of Monday, March 14, staff break room restrictions are lifted. However, please continue to use good judgement to avoid overcrowding and/or large groups of people. Masks will be optional.

When will meeting room restrictions be lifted?

We are currently evaluating the possibility of in-person meetings and more information will be coming in the next few weeks.

Are students allowed to shadow again?

Vaccinated pre-med students will be allowed to shadow upon approval. Please contact Julie VanAusdal, Medical Staff Coordinator, at ext. 4432 or Dena Wheeler, Physician Services Assistant, at ext. 4956 for more information.

Are drug reps allowed back in the clinics?

There is no change to the current process for drug reps. They can drop off; however, they cannot do face-to-face presentations in breakrooms.
