2008 Operating Expenses

Salaries, Benefits and Contract Labor comprise approximately 2/3 of the hospital's total operating expenses. Clark Fork Valley Hospital is the largest employer in Sanders County. When salary dollars are spent locally, it is estimated they generate a multiplier effect of 6 times as they circulate to support the local economy. In addition to over \$9.7 Million in staffing related expenses, CFVH paid nearly \$800,000 to local vendors for services and supplies during 2008.

CPAP Services

Clark Fork Valley Hospital now offers CPAP (Continuous Positive Airway Pressure) Therapy services. Our Cardiopulmonary team has worked with a number of patients who suffer from moderate to severe sleep apnea and who have benefited from CPAP therapy. Therapy includes using a machine that helps people breathe more easily during sleep.

With the Foundation's pledge to generously donate a new C-arm, permanent pacemaker surgery is on the horizon of services offered by Clark Fork Valley Hospital. Clark Fork Valley Cardiology will work closely with Wildhorse General Surgery to provide this lifesaving service to the residents of Sanders County. Our team of skilled professionals are gearing up to begin services in Summer 2009. Pacemaker Surgery will be provided in addition to our pacemaker clinic already offered at Plains Family Medicine.
