## FINANCIAL ASSISTANCE PROGRAM (FAP)

Clark Fork Valley Hospital and Family Medicine Network is committed to providing financial assistance to persons who have healthcare needs and are unable to pay for medically necessary care based on their household financial situation.

Persons interested in applying for financial assistance must submit a completed application and required documentation (listed on the application). Applications can be mailed to you free of charge, may be obtained from registration locations, accessed directly from our website, or you can request assistance from one of our financial counselors.

Qualified applicants can receive discounts ranging from 39% to 100% based on ability to pay. If eligibility for financial assistance is determined, these discounts are applied to emergent and medically necessary services provided by Clark Fork Valley Hospital and Family Medicine Network. The program discounts ensure that no patient eligible for financial assistance will be asked to pay more than the hospital's "Amount Generally Billed" to Medicaid, Medicare and Commercial payers. Private insurance co-pays and services not deemed medically necessary by a medical provider shall not be covered under this financial assistance program.
