Catherine Snyder and Mary Tassan expressed their interests to the Board in being a candidate for the vacant commissioner position for the district.

Consent Agenda

Motion 26/2022

Dan Bohnet made the motion to approve the Consent Agenda to include meeting minutes from June 28, 2022, written report from Susan Scheib, CNO-Vicki Polhamus and EFTs in the amount of \$9,937.50. Amanda Green seconded the motion.

Commissioner Vacancy

After the candidates excused themselves the board made their decision on candidate.

Motion 27/2022

Amanda Green made the motion to appoint Catherine (Cathy) Snyder to Board of Commissioners. Dan Bohnet seconded the motion.

Finance Committee Report

Discussion included ED remodel project and kitchen bids and wage scale adjustments. Bids have been put out in the local paper and MRSC.

Board Action Form: Visante (340B)

Motion 28/2022

Gary Jacobsen made the motion to approve retaining Visante to provide support for the District's 340B program for a period of 6 months. Dan Bohnet seconded the motion.

Physician Recruitment

Two providers retiring effective January 1, 2023 and the clinic is investigating needs to expand clinic hours.

Motion 29/2022

Amanda Green made the motion to approve the district to hire a firm to conduct a search for physician candidates for two full time positions due to retirement and increasing clinic hours. Dan Bohnet seconded the motion.

ACO 2023 Escrow

Due to good performance of the District, accepting 1% risk by participating in an enhanced model of ACO, the District has the opportunity to obtain more shared savings by Medicare only keeping 25% of the savings instead of 60% of the savings. The District would have to move \$45,000 in escrow for 2023 ACO participation.

Motion 30/2022

Amanda Green made the motion to approve the district to move \$45,000 in escrow for 2023 ACO participation for the District to have the opportunity to obtain more shared savings. Dan Bohnet seconded the motion.

Wage Scale Adjustment

Increase in wage scales as presented, NTE \$160,000 for the remainder of 2022. Wage increases will be effective 9/4/2022 pay period, that is paid out on 9/23/2022. These wages are based on comparing similar industry benchmarks using the Milliman and other resources.

Dan Bohnet made the motion to approve the increase in wage scales, NTE \$160,000 per the remainder of 2022 as presented. Amanda Green seconded the motion.
