Administrative Matters

- This Project is being procured pursuant to Government Code Section 4217, et seq.
- Because this is not a traditional design-bid-build project, all Proposal Documents will remain confidential until KHS has awarded the Project to the Proposer whose proposal is determined by KHS to have offered the best value to the public
- To preserve the confidentiality of experience, creativity, and forward –looking technology provided by each Proposer during the evaluation process, responses to any Public Records Act Requests seeking Proposal documents will be provided following Project Award by the Board of Directors
- Proposers invited to move forward with an interview will be asked to waive any protest of the ultimate Project award



Background

- KHS is a public agency formed under Section 14087.38 of the California Welfare and Institutions Code and began full operations on September 1, 1996.
- KHS serves over 300,000 Medi-Cal participants by providing high-quality health care coverage to families throughout Kern County.
- KHS operates out of its newly constructed 4-story, 100,000 SF office building housing over 400 employees located on a 5.82-acre parcel at 2900 Buck Owens Blvd, Bakersfield, CA 93308.
- KHS completed construction in September 2019 with the inclusion of a 151kW-DC carport solar system capable of producing approximately 11% of the electricity KHS presently consumes.
- KHS' Board tasked the Procurement and Facilities Department to initiate an RFP for an additional solar system capable of producing the remaining electricity it consumes.



Background

Purpose

- KHS is committed to being a good corporate citizen with the goal of producing 100% of its electricity consumption through clean, renewable solar electricity.
- KHS initiated this Request for Proposal (RFP) to solicit proposals from qualified bidders to help us achieve this goal.
- This presentation introduces the pertinent details of the RFP with a possible solution combining a carport PV system and a battery energy storage system (BESS); however, we encourage proposers to leverage their experience, creativity, and forward –looking technology to accomplish the production requirements of this RFP.



Basic RFP Scope

- An all-inclusive, minimum 674.5 kW_{DC} (540 kW_{AC}) production carport solar PV system and a 120 kW_{AC}/248 kWh production BESS with a discharge duration of two hours that shall be net-metered with the existing PG&E (utility) electrical service.
- The project includes all necessary site development due diligence, permitting, utility interconnection, under-canopy lighting, web-based monitoring, performance guarantee, related safety systems, rebates, incentives, and be aesthetically similar to the existing carport solar PV system.
 - By submitting a Proposal, Proposers agree to deliver ALL items in the RFP, including all costs, expenses, fee, profit, general conditions, general requirements, bonds and insurance and overhead, and any other components of the Work.

- DC System Size: 674.5 MWDC
- AC System Size: 540.0 MWAC
- DC:AC Ratio: 1.25
- Annual Energy Production: 1,141,037 kWh
- Module: Bloomberg tier one 72-Cell bifacial (or similar)
- Racking: RBI Solar Canopy (or similar)

- Location: Main Electrical Room
- BESS Power: 120 kW-AC
- BESS Capacity: 248 kWh
- Discharge Duration: 2 hours
- Annual Energy Discharge: 79,264 kWh

Alternate Proposals

 Alternate 1: Design, procure, and install separate conduits for 4 level 3 EV charging stations from the carports to the electrical room. Additionally, contractor to provide more conduit installation for future EV charging stations.

Alternate 2: Proposer provided annual Operations and Maintenance (O&M) program.

- Decision Point Date for Alternate 2: Substantial Completion
- KHS has no obligation to exercise either Alternate
 - KHS in its sole discretion may exercise one or both Alternates so long as it notifies
 Proposer on or before the Decision Point Date for each Alternate



Schedule / Timeline

- Project will be designed and constructed in a working parking lot
- It will be important to phase Project to minimize disruption / displacement of parking for KHS personnel
- It will be important to expedite design and construction to minimize disruption / displacement of parking for KHS personnel
- KHS anticipates design and construction will be completed within approximately one year of the issuance of Notice to Proceed with Design
- Each Proposer's proposed timeline / schedule / phasing plan will comprise one of the evaluation factors



Prevailing Wages and Securities

- The successful Proposer must comply with all prevailing wage laws and all other statutory requirements contained in the Contract
- Agency will permit successful Proposer to substitute securities for retention monies withheld
- Retention is 5% per Civil Code



Equal Employment Opportunity

 Proposers must comply with all applicable federal, state, and local laws, rules and regulations in regard to nondiscrimination in employment because of race, color, ancestry, national origin, religion, gender, sexual orientation, marital status, age, medical conditions, disability, or any other reason
