Important Facility Site and Medical Record Review Changes

Dear Provider,

The Department of Health Care Services (DHCS) has updated the Facility Site Review (FSR) and Medical Record Review (MRR) criteria that Kern Health Systems (KHS) Certified Site Reviewers (CSR's) use as the tools to conduct audits. Updates to both FSR and MRR be implemented July 1, 2022. The updates are based on recommendations from national experts in prevention and evidence-base medicine which align with local, state, and federal guidelines to ensure the provision of preventive services are in accordance with

- American Academy of Pediatrics, Bright Futures
- US Preventive Task Force
- American College of Obstetricians and Gynecologist/Comprehensive Perinatal Services Program
- Advisory Committee on Immunization Practices

In order to better assist you in preparing for those changes, KHS is providing the new DHCS tools and standards along with other resources. Please review the documents with your staff. This is your opportunity to modify existing policies and create new procedures as needed.
