Kern Health Systems Credentialing is now fully operational to utilize CAQH Proview Applications. A Provider Bulletin was posted on our website on May 23, 2023, with a variety of resources, quick references, and how-to videos. We are updating all forms for requesting an application including additional supplemental forms that will soon be available on the KHS website. In order for CAQH Proview to be utilized by KHS, you must ensure your attestation is current and authorize global access or designate Kern Family Health Care access. For those providers who don't utilize the CAQH Proview Application, you may still submit the newer California Participating Physician Application along with the additional supplemental forms. You may send your request for the application to your Provider representative or Credentialing at credentialing@khs-net.com
