I. POLICY

Kern Health Systems (KHS) will provide covered Substance Use Disorder (SUD) services, including alcohol and drug use screening, assessment, brief interventions, and referral to treatment (SABIRT) for members ages 11 and older, including pregnant members, in primary care settings and tobacco, alcohol, and illicit drug screening in accordance with American Academy of Pediatrics Bright Futures for Children recommendations and United States Preventive Services Taskforce grade A and B recommendations for adults as outlined in All Plan Letter (APL) 21-014, Alcohol and Drug Screening, Assessment, Brief Interventions and Referral to Treatment. Further, KHS will provide or arrange for the provision of:

- A. Tobacco cessation counseling.
- B. Medications for Addiction Treatment (also known as Medication-Assisted Treatment) provided in primary care, inpatient hospital, emergency departments, and other contracted medical settings.
- C. Emergency services necessary to stabilize the member, including voluntary inpatient detoxification through the Medi-Cal fee for service program in accordance with policies outlined in Department of Healthcare Services (DHCS) APL 18-001.¹

KHS will identify and refer an eligible Member to the Kern County Drug Medi-Cal Organized Delivery System (DMC-ODS) for the provision of Drug Medi-Cal services.

KHS and its contracted Primary Care Providers (PCPs) shall provide Screening for Substance and Alcohol Misuse, Brief Intervention, and Referral for Treatment (SABIRT) for Members identified as atrisk of substance and alcohol misuse.

The Alcohol and Substance Use Disorders policy and procedures will conform to requirements outlined in the following statutory, regulatory, and contractual sources:

II. **DEFINITIONS**

III. PROCEDURES

- A. For Substance and Alcohol Misuse, a KHS Network PCP shall:
 - 1. Administer the DHCS-approved screening tool for identifying substance and alcohol misuse in accordance with DHCS All Plan Letter (APL) 21-014: Alcohol and Drug Screening, Assessment, Brief Interventions and Referral to Treatment (SABIRT).
 - 2. Provide behavioral counseling intervention on identified issue(s); and,
 - 3. Refer members to KHS for linkage to Kern Behavioral Health and Recovery Services (BHRS). KHS will outreach to member and complete the warm hand off to the SUD Access Line for initial brief American Society of Addiction Medicine (ASAM) Screening and linkage for additional assessment and counseling when indicated.

- B. For tobacco cessation, a KHS Network PCP shall:
 - 1. Identify members through an evaluation at a regular office visit or during the initial health assessment.
 - 2. Provide behavioral counseling.
 - 3. Offer treatment to assist with tobacco cessation or refer to KHS for referral to local group tobacco cessation counseling resources.
- C. For Medication Assisted Treatment (MAT), KHS Network PCP shall:
 - 1. Provide members who are seeking treatment for opioid use with prescription for
 - 2. Offer prescription for buprenorphine or naltrexone.
 - 3. Refer members to KHS for linkage to Kern BHRS. KHS will outreach to member and complete the warm hand off to the SUD Access Line for initial brief ASAM Screening and linkage to counseling support for opioid use disorder (OUD).
- D. For Voluntary Inpatient Detoxification (VID):
 - 1. If member contacts KHS directly seeking VID services, KHS will refer members to VID service provider. The VID provider facility must not be a Substance Use Disorder Treatment Facility or an Institution for Mental Disease.
 - 2. The VID service provider must submit a Treatment Authorization Request (TAR) for authorization. KHS will provide care coordination with the VID service provider as needed.
 - 3. Documentation that is submitted with the TAR should verify that admission criteria are met as well as demonstrate the medical necessity for the inpatient stay in general acute care hospital.
- E. Care Coordination with Kern BHRS for Substance and Alcohol Misuse Services:
 - 1. PCPs will submit referrals via portal for SUD services to KHS for linkage to Kern BHRS. KHS will outreach to member and complete the warm hand off to the SUD Access Line for initial brief ASAM Screening.
 - 2. If member contacts KHS directly seeking SUD services, KHS will provide linkage to KHBRS and complete the warm hand off to the SUD Access Line for initial brief ASAM Screening.
 - 3. KHS Behavioral Health (BH) Providers will provide the linkage for SUD service through Kern BHRS, if determined member requires services and upon member's request. KHS will receive monthly reporting from BH providers to assist with tracking coordination with SUD services.
 - 4. Through the automated data exchange process, KHS will send the monthly SUD referral outcome report to Kern BHRS for reconciliation on all referrals submitted requesting data to confirm member was linked for treatment (when and where). For members KBHRS is unable to obtain Release of Information, KHS will contact member to confirm whether treatment was received and track when and where.
