All Plan Letter 22-016 Community Health Worker Services Benefit

Dear Provider,

The Department of Health Care Services (DHCS) released APL 22-016 on September 2, 2022, to provide Kern Health Systems (KHS) members with access to the Community Health Worker (CHW) Services Benefit.

Per State Plan Amendment (SPA) 22-0001, Community Health Worker (CHW) services are preventive health services as defined in Title 42 Code of Federal Regulations (CFR) to prevent diseases, disability, and other health conditions or their progression; to prolong life; and to promote physical and mental health. The goal of the service is to enhance quality patient care by offering support to members to address barriers in accessing care, increasing level of engagement, improving health outcomes, reducing health disparities, and achieving health equity.

Network Providers who have CHWs on their workforce, or plan to in the future, will need to submit the CHW Application/Check List and the CHW Supervisor Attestation Form to KHS Provider Network Management Credentialing Department for review and approval. Once approved by KHS, the following CPT codes may be used for all CHW services by the Supervising Provider when submitting claims:

98960	self-management education and training, face-to-face, 30 minutes	30 minutes	1
98961	self-management education and training, face-to-face, 30 minutes	30 minutes	2-4
98962	self-management education and training, face-to-face, 30 minutes	30 minutes	5-8

Please bill with the appropriate modifier:

Modifiers	Description	
U2	Used to denote services rendered by Community Health Workers	
U3	Used to denote services rendered by Asthma Preventive Service Providers	



Maximum frequency is four units (two hours) daily per beneficiary. Additional units per day may be provided with KHS approval for medical necessity.
