# Lake Regional Health System Community Health Needs Implementation Plan December 2018

In spring 2018, Lake Regional Health System formed a committee, called Lake Area Community Health Partners, to conduct the Community Health Needs Assessment. The assessment identified health issues within the community, defined as 23 ZIP codes located in Camden, Miller and Morgan counties and within a 25-mile radius of Lake Regional Hospital in Osage Beach, Missouri. Common themes were identified, scored and weighted to prioritize the health needs of the defined community.

# IMPLEMENTATION STRATEGY

To address priority health needs identified by the survey, Lake Regional Health System will implement the strategies outlined in Appendices A, B and C, beginning in fiscal year 2019. Certain programs will continue through FY 2020 and FY 2021. Outcome measures will be reviewed semiannually to determine the success of established goals.

### **COMMUNITY BENEFIT**

The Lake Regional Health System Board of Directors reviews the Implementation Plan annually to ensure the organization's strategic objectives remain aligned with the community's health needs.

# HEALTH NEEDS PRIORITIZATION

Lake Area Community Health Partners committee members reviewed the 2018 Community Health Needs Assessment survey report to identify and prioritize community health needs. The following health concerns were identified as top priorities and are included in the Implementation Plan.

- mental health
- substance abuse
- ability to pay and/or lack of insurance

Following is a description of additional health concerns identified in the Community Health Needs Assessment survey and how they are being addressed by Lake Regional Health System or others in the community.
