And in 2015 we again lived up to our purpose as a locally based, not-forprofit hospital. MRH provided a total of more than \$21.7 million in community benefit services to improve local health through community health education and screenings, charity care, subsidized health services, community support and supporting the education of tomorrow's healthcare professionals. (See Page 8 for the details.)

With an eye to the future, we teamed up with numerous community organizations in Logan County's second Health Risk and Community Needs Assessment. In addition, as you'll read in this annual report, we developed plans for new facilities and services that answer healthcare needs we've heard expressed in the communities we serve.

These new facilities and services include an urgent care center and medical building that will provide convenient access to in-demand health care services away from the hospital campus. The urgent care center will offer a much-needed alternative to the emergency room for treatment of minor illnesses and injuries. To reduce the wait for local urgent care services, we'll be offering a temporary Convenience Clinic next to the ER until the new urgent care center opens in late 2017. We're also in the process of expanding our range of quality healthcare services in Urbana due to growing demand there.

Speaking of quality healthcare, the Centers for Medicare and Medicaid Services (CMS) in 2015 awarded MRH a Value-Based Purchasing (VBP) score for patient care quality that ranks us in the top seven among Ohio hospitals. MRH earned the highest VBP score in Logan and the surrounding five counties.

MRH also met or exceeded every clinical quality indicator, receiving a four-star rating from CMS. And for the third straight year, Healthgrades presented MRH the Outstanding Patient Experience Award, placing us among the top 10 percent of U.S. hospitals.

Everything I write about here results from a shared commitment to community service and a dedication to excellence throughout the services and facilities of Mary Rutan Hospital—from our talented and compassionate board, leadership team, employees, medical staff and volunteers. Together we cherish our mission to improve the health of our community.

And we couldn't accomplish all of this without the loyal support and confidence of the patients and families we serve. On behalf of our entire team, I thank you all.

MRH EXPANDING PRESENCE IN URBANA

Mary Rutan Hospital answered an unmet need in Champaign County last May, opening a clinic at 848 Scioto Street in Urbana that offers ob-gyn and adult and pediatric primary care.

Immediately the phone began ringing. And appointment books filled faster than anticipated.



So, we went back to the drawing board. Now, a year later, we're preparing for the July opening of a larger facility in Urbana—four times the size of the first with a wider range of services for Champaign County area patients.

"This is a clear advantage of a locallybased healthcare provider like Mary Rutan Hospital: We can respond quickly to the evolving healthcare needs of our local communities," said Mandy Goble, president and CEO of Mary Rutan Hospital. "We are always challenging ourselves to make the healthcare experience better and more convenient for our patients. We are grateful to the Champaign County community for their support and for the opportunity to

invest further in expanding excellent, local healthcare."

The new Urbana facility, at 1880 East US Hwy. 36, will serve as a satellite facility of Mary Rutan Hospital, located 20 miles north in Bellefontaine.

The new Urbana Clinic will offer specialists in pediatrics, adult primary care, obstetrics and gynecology, general surgery, urology and orthopedics, as well as x-ray, full lab services and physical therapy.



PLANS UNVEILED FOR NEW MEDICAL FACILITY AND URGENT CARE

Plans are solidifying quickly for a 60,000-square-foot medical facility and urgent care center to be built by Mary Rutan Hospital on 11.5 acres of land acquired in 2015 near the intersection of Route 33 and 68 North. The site was formerly home to the Holiday Inn, which was torn down in 2014.

"We heard our community's expressed need for local urgent care services as an alternative to emergency medical care, and we are responding with this new facility, the Mary Rutan Hospital Health Center," said Mandy Goble, president and CEO of Mary Rutan Hospital. "In addition to urgent care services, the new health center will provide convenient access to other needed health care services."


The new urgent care center will offer evening and weekend hours for treatment of minor illnesses and injuries that do not justify an emergency room visit. Other services being planned for the physician clinic, imaging, Corporate Health Services, chronic care clinics and wellness services. The facility will provide community members much more convenient access for popular services now available only in the main hospital, such as weight loss programs and Coumadin and diabetes clinics.

Architects from DesignGroup of Columbus are drawing up plans, Chad Ross, MRH vice president of operations, said. He expects dirt to be moved and construction to begin by late this year or early 2017.

Ross said that the Mary Rutan Hospital Health Center will be part of a development called Northpoint Center. "The site has the potential to support retail development. Mary Rutan Hospital will be working closely with the Chamber of Commerce and local governmental leaders with the hope that additional retail establishments will be a part of the site development."

NEW CONVENIENCE CLINIC

To bridge the gap until MRH's new urgent care center opens in 2017 (see Page 4), MRH will temporarily operate a non-emergency, convenience clinic next to the MRH Emergency Department, beginning in June.

An alternative to the emergency department, the Mary Rutan Hospital Convenience Clinic will operate as a walk-in medical clinic for patients when their primary care physicians are unavailable and when they are not sick or injured enough to receive care in the emergency department.

"It is not our intent to compete with family doctors, but rather complement the services these physicians provide by giving patients an option for the treatment of uncomplicated care when their primary care providers aren't available," said Tom Denbow, Vice President of Physician Integration at Mary Rutan Hospital.

The clinic will be a low-cost alternative to an ER visit for minor, everyday ailments such as allergies, sinus infection, cough and cold, sore throats, bronchitis, respiratory infections, ear pain, eye infections, fevers, flu-like symptoms, upset stomach, vomiting and diarrhea, insect bites, sprains and strains, first and minor second degree burns, small bone fractures (toes, foot, finger), minor cuts, minor lacerations/ stitches, scrapes and bruises, skin rashes, urinary burning, asthma, minor back pain and migraine headache.

The Convenience Clinic, next to the MRH Emergency Department, will be open seven days a week, 11 a.m. to 8 p.m. Appointments are not necessary and the clinic will accept most types of insurance. For more information, call 937-651-6820.





MARY RUTAN HOSPITAL EARNS TOP STATE QUALITY RANKINGS

The nurses, physicians and staff of Mary Rutan Hospital again distinguished themselves for providing quality patient care in 2015:

- MRH's Value-Based Purchasing (VBP) score for patient care quality ranked in the top seven among Ohio hospitals. This places MRH in the top 7% of all qualifying hospitals in the state.
- Mary Rutan's VBP score is the highest in Logan and the surrounding five counties.
- MRH met or exceeded every clinical indicator and received a **four-star rating** from the Centers for Medicare and Medicaid Services.
- MRH was recognized for the third straight year with the Outstanding Patient Experience Award from Healthgrades, placing the hospital among the top 10 percent of hospitals in the nation.
- Most recently, recognized nationally as a 2016 top 100 Rural & Community Hospital.

"I am very proud of the work our team does every day to provide our patients excellent care," said Mandy Goble, president and CEO of Mary Rutan. "To be able to achieve these results and to be recognized at this level demonstrates the skills, dedication to quality and hard work of our entire staff."

Why High VBP Scores Matter

A high Total Performance Score in the VBP Program, such as that earned by MRH, matters to patients, as it reflects the high quality of care they receive. The score covers four primary areas: patient experience, patient outcomes, clinical process of care and financial efficiency.

A high Total Performance Score in the VBP Program also matters to hospitals themselves. Medicare reimburses Medicare-associated health care costs at a higher rate for hospitals such as MRH that improve quality of care. And this comes back to benefit patients by improving the financial health of hospitals.

The rankings are compiled by Hospital Compare, an organization created by the Centers for Medicare & Medicaid Services (CMS) in collaboration with groups that represent consumers, hospitals, doctors, employers, accrediting organizations and other federal agencies. More than 3,000 hospitals across the country participate.

VBP encourages hospitals to improve the quality and safety of care provided to Medicare beneficiaries and other patients during acute care inpatient stays. The program encourages hospitals to adopt evidence-based care standards and protocols that result in optimal patient outcomes, eliminate or reduce errors that may harm patients and re-engineer hospital processes to improve patients' care experience.

"These awards are all a tribute to Mary Rutan Hospital's team of expert doctors, nurses and staff, who are dedicated to delivering nationally recognized quality care and service excellence every day," Goble said.

and well-being of the community while placing service to humanity ahead of personal gain or recognition.

Nicholl, Director of Service Systems for the Mental Health, Drug and Alcohol Board of Logan and Champaign Counties, was recognized for her leadership in bringing together area agencies, organizations and community members to create local resources and services that help Logan County residents with a range of health and social concerns such as opiate and heroin abuse, mental health, homelessness and healthy lifestyle choices.

For nearly 30 years, Nicholl has served the community through her roles with local social service agencies and through volunteer leadership, including chair of the Healthy Living Coalition, co-chair of the Coalition for Opiate Relief Efforts, secretary of the Logan County Continuum of Care Board, secretary of Discovery Riders therapeutic equestrian program and involvement in the local Recovery Housing Planning Team and Suicide Prevention Coalition.

"I can't see myself doing anything else," Nicholls said of her community service. "I see it as mission work, caring about people and making a difference in my community. What gives me fire is seeing people that work together to make a difference, working with families to get where they never thought they would be."

She added, "None of it is about me. None of the accomplishments are me or about any one person. It is through working together and collaboration that we make a difference."


- Healthy living to prevent obesity and chronic disease

From these findings, a Community Health Improvement Plan, with detailed action items, has been established to guide community partners in a collaborative effort to address the identified needs and risks.

In addition, Mary Rutan Hospital has developed an internal plan for improving the health of Logan County, responding to the health-related needs of the poor, the underserved and the community-at-large. We pledge to develop services, provide financial and professional support, and offer education and wellness programs to pave the way to a healthier community.

Charity Care a<mark>nd </mark>Financial As<mark>sistance</mark>

members, regardless of financial circumstances. We preserve the dignity of all patients, making financial counselors available in the hospital or by phone to help with payment plans and to provide access to federal, state and local assistance programs. Charity care and financial assistance in 2015 totaled over \$2.1 million. This number does not include the \$18.6 million in unpaid costs of Medicaid and

to become active participants in their own health and wellness. Offering tools people need to better manage their health payes the way to a healthier community for everyone.

In 2015, our healthcare team traveled to more than 260 locations, providing more than 73,000 touch points of health education, support and screenings, for a total investment of more than \$252,000.

Community Building and Support

We believe in volunteering, supporting our community and collaborating with other organizations to improve the health and quality of life of the surrounding area. As a part of this commitment, Mary Rutan Hospital provides financial and in-kind support to area schools and nonprofit organizations. In addition, we encourage our employees and leadership team to volunteer in the community and provide professional support to area agencies and organizations. These contributions added up to more than \$430,000 in 2015.

Education for Health Professionals

Mary Rutan Hospital is a major supporter of medical professional education. In 2015, we invested more than \$234,000 in student internships, clinical rotations and medical scholarships and loans, inspiring future generations to begin careers in health care and provide for the future health needs of our community.

Other Forms of Economic Support

Mary Rutan Hospital is a major driver of the local economy, with more than 700 employees and a payroll of \$38.5 million

in 2015. These dollars have a ripple effect on the economic health of local communities as employees make their homes here, support local merchants and pay more than \$9.85 million in state, local and school taxes.
