The <u>out-of-pocket limit</u> is the most you could pay during a coverage period (usually one year) for your share of the cost of covered services. This limit helps you plan for health care expenses. The federal <u>maximum out-of-pocket</u> is \$9,200 individual/\$18,400 family. This applies to all essential health benefits, including some services not included in the <u>out-of-pocket limit.</u> (i.e. certain level 3 & 4 <u>prescription drugs</u> and adult hearing aids covered under this <u>plan</u> ).

# Does this plan provide Minimum Essential Coverage? Yes
