Santa Clara Family Health Plan (SCFHP) is excited to announce our new Medi-Cal Wellness Rewards Program. Beginning May 2019, SCFHP Medi-Cal members who complete qualifying health and wellness activities will be rewarded with gift cards to their choice of major retailers. The program aims to improve quality and close gaps in care by encouraging SCFHP members to see their doctor in a timely manner for required screenings and wellness exams.

The SCFHP Wellness Rewards Program will include member incentives for the following measures:

- 1. Adolescent Well-Care (AWC)
- 2. Asthma Medication Ratio (AMR)
- 3. Breast Cancer Screening (BCS)
- 4. Cervical Cancer Screening (CCS)
- 5. Comprehensive Diabetes Care (CDC)
- 6. Prenatal Program (PPC)
- 7. Well-Child Visits for first 15 Months of Life (W15)
- 8. Well-Child Visits for Ages 3-6 (W34)

Once the member completes their screening and a claim/encounter is received, SCFHP will automatically mail a notification to the member to select their gift card. Please submit timely and accurate claims as it benefits member's incentives and improves HEDIS measurements.
