Subject:	Health Homes Program – A New Benefit for high risk Santa Clara Family Health Plan SCFHP Medi-Cal members

Dear SCFHP Provider,

Effective July 1, 2019, in accordance with California Assembly Bill 361 (AB361) under Section 2703 of the 2010 Patient Protection and Affordable Care Act, Santa Clara Family Health Plan (SCFHP) will be offering a new Medi-Cal benefit called the **Health Homes Program** (HHP).

Eligible members will be assigned to a community based care management entity (CB-CME) who will provide community based care management services. Once enrolled in HHP, the member will be provided a care team that includes a care coordinator or care manager and a housing coordinator. The care team will work with the member to manage and coordinate the member's care and connect the member to community and social services.

Following is important information regarding the Health Homes Program.

Health Home Program Basics

- Members who are eligible for HHP services will receive a letter from SCFHP explaining their eligibility for the HHP and how to sign up.
- Members who enroll in the HHP will continue to see their same doctors, but will have an added layer of support with a HHP case management team.

- Medi-Cal members may also contact SCFHP Customer Service at **1-800-260-2055** to see if they are eligible and to enroll.

Required HHP Services

SCFHP will work with contracted Community-Based Care Management Entities (CB-CMEs) to provide HHP members with the following set of required services:

- Comprehensive Care Management
- Care Coordination
- Health Promotion
- Comprehensive Transitional Care
- Individual and Family Support Services
- Referrals to Community and Social Support services
- Housing Navigation and Tenancy Support (for enrollees experiencing chronic homelessness)

Health Homes CB-CMEs:

CB-CMEs will be the frontline providers of HHP required services. These agencies will conduct outreach to SCFHP members who are HHP eligible, as well as deliver HHP services.

HHP Eligibility:

To be eligible for HHP services, a member must meet at least one condition from each of two columns below:

<u>Diagnosis</u>

- □ Have at least two of these conditions:
 - Chronic obstructive pulmonary disease (COPD)
 - o Diabetes
 - Traumatic brain injury
 - Chronic or congestive heart failure
 - o Coronary artery disease
 - Chronic liver disease
 - o Chronic kidney disease
 - o Dementia
 - Substance use disorders
- Have hypertension (high blood pressure) and one of these conditions:
 - o COPD
 - o Diabetes
 - Coronary artery disease
 - Chronic or congestive heart failure
- □ Have one of these conditions:
 - o Major depression disorders
 - o Bipolar disorder
 - Psychotic disorders (including schizophrenia)
- □ Have asthma

Other Criteria

- □ Has at least 3 or more of the HHP eligible chronic conditions
- Have experienced an inpatient hospital admission in the last 12 months
- Visited an emergency department three or more times in the last 12 months
- □ Be chronically homeless

If you answer YES to all or almost all of the questions below, HHP may be right for you!

- □ Do vou have Medi-Cal?
- Do you have multiple chronic conditions and/or have a mental health condition for which you need regular doctor's care?
- □ Do you have difficulty keeping and making it to your medical appointments?
- □ Have you visited an emergency room or hospital three or more times in the last 12 months?
- □ Do you need a safe place to live?
