Dear providers,

Santa Clara Family Health Plan is excited to announce the 2021 Wellness Rewards Program for Medi-Cal members. The program aims to motivate SCFHP members to see their doctor in a timely manner for required screenings, wellness exams, and disease self-management. Members who meet the eligibility criteria for each measure will receive a mailer from SCFHP to learn how they can qualify for the reward.

The SCFHP Wellness Rewards Program will focus on the following measures:

- Comprehensive Diabetes Care HbA1c Testing (CDC-HT)
- Comprehensive Diabetes Care Poor Control (CDC->9)
- Well-Child Visits 0-15 months (W30)
- Well-Child Visits 16-30 months (W30
- Adolescent Well-Care Visits 18-21 years (WCV)
- Healthy Moms, Healthy Babies Prenatal Program (PPC)
- Well-Woman Breast Cancer & Cervical Cancer (BCS.CCS)

Please see the attached summary sheet for more information about these programs, including terms, conditions, and eligibility requirements. No signed attestation is required. Qualifying claims must be submitted to SCFHP with correct codes as identified by NCQA HEDIS Technical Specifications for each measure within 90 days after service is rendered.

Staff can also log in to SCFHP Provider Link at <u>providerportal.scfhp.com</u> to identify members who have an existing gap in care for any of the measures listed above.

Qualifying and compliant members will receive notification by U.S Mail on how to claim their reward within three months from the date of the submitted claim.

*All networks are eligible, except Kaiser. Cal Medi-Connect members or members with SCFHP as secondary insurance do not qualify. SCFHP follows NCQA technical specifications for all measures to determine eligibility. Members must currently be enrolled with SCFHP to qualify. Members who termed with SCFHP are not eligible for rewards regardless of when visit was completed. Other tems and conditions may apply. No provider attestation form is required. Provider must bill visit per HEDIS Technical Specifications and codes in order for visit to qualify for reward. Qualified members will receive notification via U.S mail on how to claim their reward within approximately 3 months from date claim is submitted.
