5. Awards to students are made in three different ways. 1) Those enrolled in BI 200 and CH 100 were awarded block grants to help cover the increased cost in lab kits due to Covid. 2) Students are asked to apply for the grant through our website. Applications are reviewed by a committee. 3) Students enrolled in classes as of March 13, 2020-Sept 22, 2021 were awarded block grants based on need. If students were enrolled in multiple aid years, we used the lowest calculated EFC (Expected Family

Contribution) in order to maximize funding from this grant. Students that did not file a FAFSA received a \$300 award, as we were unable to determine financial need.

6. Students have been asked to complete an application for additional expenses they have incurred during the COVID-19 crisis. Students have been asked to identify the reason for the request: food, housing, course materials, technology purchases, healthcare costs, childcare costs, or other COVID-19 related expenses. Awards are administered on a first-come, first-serve basis and it is strongly recommended that students have a FAFSA on file.

Students enrolled in BI 200 and CH 100 that had an increase in lab expenses due to Covid-19 were reimbursed for the cost of their lab supplies. Initial recipients were required to have a FAFSA on file, as that was the guidance given at the time of disbursement.

Students enrolled anytime between March 13, 2020 and September 22, 2021 received a block grant based on financial need as determined by the FAFSA. If a student did not have a FAFSA on file, they received a grant equivalent to the highest EFC breakout.
