### Senator Mitch McConnell brings anti-Obamacare message to Morehead

U.S. Sen. Mitch McConnell came to Morehead Friday, August 16 with his message of opposition to what he and other Republicans call Obamacare.

He answered questions from local health officials about the Patient Protection and Affordable Care Act (ACA).

Before taking questions at the Center for Health, Education and Research (CHER), Kentucky's senior senator and Senate minority leader reiterated his concerns about the ACA.

"This bill passed on a totally partisan basis," he said. "I don't think it was because anyone was inherently opposed to anything the other side recommended but I think it was because they thought it was a really big mistake for the country."

McConnell said the bill was passed in order to fix the health insurance affordability problem in the US. He noted that 40 million Americans remain uninsured.

He admits the overall objective of ACA was good but that it just didn't work for the current U.S. health insurance model.

He said having government-run insurance, private health insurance companies has caused a spike in premiums.

Also, McConnell claims the bill has taken \$750 billion away from hospitals, medical providers and the like.

McConnell assured those in attendance that the Congress eventually will revisit the 2,700-page law.

Dr. Cathy Shely, director of pharmacy at St. Claire Regional Medical Center, told McConnell most of the problems she sees are from dealing with the "middle man," the insurance industry.

She said she doesn't see how the public can utilize health care in a free-market way when insurance companies hardly lend support.

McConnell responded by explaining private sector competition benefits.

He said that pitting companies against each other results in beneficial pricing for consumers but the government retains price controls when coverage leaves the private sector.

"Regardless of whether people are in one party or another, we do respond to constituent pressure, we just do," he said, referring to the relationship between Washington politicians like himself and voters. "I think there's a hopeful sign here that public pressure will keep building and that we will respond to that—and we should as part of a democracy."


### **AABB** Annual Recertification

Partnering with Jon Dodds of Stryker Medical, seven existing acute care beds received technology upgrades consisting of an integrated weight scale and 3 zone bed exit alarm system. The staff received education around evidence-based best practices for fall prevention, specifically the importance of maintaining a safe bed position for those patients identified as high risk for falls. The 5th Floor team will be charting their progress along the way using a very visible 60 day countdown calendar located at the nurse station.

The board is also responsible for investigating any complaints by the public regarding persons claiming to be a dietitian or nutritionist without proper credentials.

#### September through February

If your birthday is September through February schedule your appointment for your birth month.

#### **March through August**

If your birthday is March through August you will need to schedule an appointment for January or February, then again in your birth month to ensure no more than 12 months pass between tests.
