The Rural Physician Leadership Program (RPLP) would like to introduce our Course Directors for the 2010-2011 year. There are currently eight physician RPLP Course Directors from a variety of medical specialties including; emergency medicine, family medicine, general/vascular surgery, internal medicine, neurology, obstetrics and gynecology, pediatrics and psychiatry. Over the last six months this group of dedicated educators has devoted their time, patience, wisdom and expertise to train the first class of RPLP students here in rural Kentucky.

RPLP Course Directors are not only responsible for the clinical education of the medical students, but their didactic education as well. Course Directors have worked closely with their counterparts at the University of Kentucky and the Morehead RPLP staff to develop a curriculum that fuses the goals and standards of the University of Kentucky with the values and ideals found in rural Kentucky communities. More specific objectives and competencies include:

- Populations-based study and research
- Health promotion and disease prevention
- Study of community health systems, services and agencies
- The role of community leaders in health care
- Identification of community health problems and their solutions
- Evaluation of the effectiveness and efficiency of a medical practice
- Economics of a medical practice, as well as the impact of a medical practice on the local economy.

Additionally, the Course Directors further guide the students of the RPLP in their search to possess the knowledge and experience necessary to work with civic and community leaders to improve the general health of their communities and the Commonwealth as a whole.
