Howell worked as a volunteer counselor the past two summers at Camp SMILE, the St. Claire Hospice bereavement camp for children between

the ages of 5 and 17. The experience helped her decide to major in clinical psychology, she said.

"I had no idea that there were so many kids in my area that had lost loved ones," Howell said. "I've now realized that, yes, one day this will all be over, so I have to make the most of my life right now because today is all we have. It is experiences like Camp SMILE that have given me the drive and desire to do something extraordinary with my life."

"I have had the pleasure of working with Chelsea at Camp SMILE and have seen that her ability to connect with the children and to provide support and encouragement are outstanding," said Nathania Bush, Morehead State University Associate Professor of Nursing. "She has a unique gift of inspiring these children who have suffered significant loss."

The Richard J. Bausch Family Scholarship is funded by an endowment that was established in memory of the father of Gregory J. Bausch, PharmD, SCR Vice President of Regional Services. To qualify for the Bausch Family Scholarship, an applicant must be a pre-professional health sciences student enrolled in a community/technical college or university program and a resident of an Appalachian county as defined by the federal government.

### REVENUE CYCLE IMPROVEMENTS

Several departments have worked to improve our Revenue Cycle processes to collect the appropriate reimbursement for the services we provide.

Unbilled/Denied Accounts - The Coding Department, Patient Financial Services, Patient Access, Case Management, and other departments review unbilled and denied accounts on a weekly basis. Processes have been put in place to resolve the issue and get the bills dropped in a timely manner. The unbilled dollar amount has reached an average of 4.8 million. This is the lowest in five years!

RAC Team - The RAC Response Team monitors compliance by reviewing and improving revenue cycle processes (orders, documentation, charges, coding and billing) to ensure accurate billing and maintain revenue integrity for SCR. The Team focuses on diagnoses and procedures identified by the OIG and the RACs as priority or high-risk topics. The RAC may request up to 200 hospital records every 45 days. SCR received the first records request on January 27, 2010 from CGI, the CMS Recovery Audit Contractor (RAC) for Kentucky. Ten (10) records were requested and included DRGs for Gastroenteritis Hemorrhage, Septicemia, Extensive OR Procedure Unrelated to Principal Diagnosis, and Respiratory System. RAC determined three (3) cases to be overpayment due to DRG assignment. Following a rebuttal conference call with CGI, SCR plans to appeal one case. SCR received a request for documentation of 43 chemotherapy accounts. Forty (40) of these accounts

were determined to be underbilled, for an additional \$27,045 additional reimbursement. SCR has not received requests for physician or HME records to date.

Executive Health Resources (EHR) - Executive Health

Resources (EHR) has been successfully integrated into case management and compliance processes to assure medical necessity and entitled reimbursement for inpatient, observation and outpatient services. SCR extended the program in February 2010 to include elective, scheduled cardiac procedures such as pacemakers, defibrillators and stents. The EHR case rate decreased due to an agreement between EHR and the University Healthsystem Consortium ("UHC").

Review - SCR has contracted with McBee Associates, Inc. to review Medicare discharges from 10/1/2007 through 9/30/2009. McBee Associates utilizes both CMS data files and formal written communications with post-acute providers to determine if the filed or previously paid claim reflects the appropriate discharge status code and if applicable, related condition codes that may affect corresponding condition codes as well as to make recommendations for changes. This documentation is otherwise not available to SCR at the time of billing. To date, McBee Associates has recovered \$117,978 in additional revenue for St. Claire Regional Medical Center.

OTHERWISE KNOWN AS HEAD LICE


Head lice are found worldwide. In the United States, infestation with head lice is common among daycares and elementary school children. CDC estimates that 6-12 million infestations occur each year in the U.S. among children 3 to 11 years old.

Head lice move by crawling; they cannot hop or fly. They are spread by direct contact with the hair of an infested person. Personal hygiene or cleanliness in the home or school has nothing to do with getting head lice. Dogs, cats, and other pets do not play a role in the spread of human lice.

The head louse, or Pediculus humanus capitis, is a parasitic insect that can be found on the head, eyebrows, and eyelashes of people. Head lice feed on human blood several times a day and live close to the human scalp. Head lice are not known to spread disease.

Many head lice medications are available "over-the-counter" without a prescription at a local drug store or pharmacy. Retreatment generally is recommended for most prescription and non-prescription drugs after 9-10 days in order to kill any surviving hatched lice. When treating head lice, additional measures can be taken such as washing hats, scarves, pillow cases, bedding, and towels used by the infested person in the 2-day period just before treatment is started by using hot water and hot air cycles. Items that cannot be laundered may be sealed in a plastic bag for two weeks. Do not use fumigant sprays; they can be toxic if inhaled or absorbed through the skin. Head lice survive less than 1-2 days if they fall off a person and cannot feed; nits cannot hatch and usually die within a week if they are not kept at the same temperature as that found close to the human scalp.
