## SUMMARY

The newly named Acting Chief Executive Officer will require signatory authority on Gold Coast Health Plan's (GCHP or Plan) banking and investment accounts as well as on all Provider and Vendor contracts in order to execute the duties of the Chief Executive Office.

# BACKGROUND / DISCUSSION

In the event GCHP does not have a permanent Chief Executive Officer, the Commission must name an Acting Chief Executive Officer. At the August 28, 2024 Special Commission meeting, the Commission selected a new Acting Chief Executive Officer.

The fulfillment of Acting Chief Executive Officer duties includes the ability to access, approve, and transfer funds to and from any banking and investment account held by GCHP. These duties also include the ability to sign and execute contractual agreements between GCHP and vendors or providers. Note that while the Chief Financial Officer retains the primary responsibility for banking and investment fund management, it is considered a best practice for two Officers to hold fiscal signatory rights on said accounts, thus the need to extend these rights to the Acting Chief Executive Officer until a permanent CEO can assume said rights.

# FISCAL IMPACT

None. The Resolution simply authorizes the proper GCHP personnel to initiate banking and fund management transactions as well as sign and execute contractual documents.



#### RECOMMENDATION

Staff recommends the Commission adopt Resolution 2024-003 granting signature authority to the Acting Chief Executive Officer.
