

Community Health Investments 2025-2026 Pathways to Wellness Community Grant Program Request for Applications (RFA)

I. Purpose

Gold Coast Health Plan (GCHP) is pleased to release its Pathways to Wellness (PTW) Community Grant Program Request for Applications (RFA) through its Community Health Investments grantmaking program. The PTW Community Grant Program builds upon the work achieved through prior community grants that provided funding to external organizations addressing the social determinants impacting the health and well-being of GCHP members.¹

The goal of the PTW Community Grant Program is to improve members' experience with their health care journeys by addressing the social, cultural, structural, and environmental barriers that prevent them from accessing the care and services they need. The PTW Community Grant Program will release an RFA every year for the next three years (2025-2027) and support selected organizations for 12-month projects.

The RFA invites proposals from organizations dedicated to removing barriers, and improving access to health care and health outcomes among vulnerable populations. This year's program objectives reflect new Medicaid requirements and the urgent need to address social, cultural, and systemic factors that prevent individuals from receiving timely care in today's political climate.²

Priority areas include:

- 1. Coordinating the navigation of health care and benefits: addressing the complexities of eligibility, uncovered health care costs, primary and specialty care, and connections between health and social services:
- 2. **Building trust and cultural alignment:** examining the root causes of fear, mistrust, and cultural barriers within the community and mapping the member's journey to intervene with culturally, community-centered solutions; and
- 3. **Supporting the provision of food and basic needs:** stabilizing access to food, basic needs, and essential services for vulnerable populations residing in Ventura County.

Through targeted investments, the PTW program seeks to advance initiatives that simplify health care navigation, foster community trust, address underlying food insecurity, and ensure members can access the care and services they need to achieve better health outcomes. Successful proposals will demonstrate a clear understanding of the community's needs, propose culturally aligned and trust-building solutions, and address key social drivers of health such as food insecurity and or service navigation.

Organizations qualified to apply will develop a strategic workplan for their targeted populations of focus that will leverage relationships within their communities to eligible Medi-Cal beneficiaries.

II. Gold Coast Health Plan

GCHP is an independent public entity created by a Ventura County ordinance and authorized through Federal Legislation. GCHP is not a county agency. The Ventura County Board of Supervisors approved implementation of a County Organized Health System (COHS) model, transitioning from fee-for-service Medi-Cal to managed care on June 2, 2009. The purpose of GCHP is to serve Medi-Cal beneficiaries, enhance the quality of health care, provide greater access, improve service and provide choice. GCHP provides health benefits to more than 240,000 beneficiaries in the county.

III. Eligibility

To be eligible for a Community Health Investments grant, applicants must meet the following minimum requirements:

- Be a 501(c)(3) tax-exempt organization with a 509(a)-designation indicating that the organization is not a private foundation, or
- · Be a public or government entity, and
- Support access to high-quality health care and/or health-enhancing supportive services primarily to Medi-Cal recipients.

IV. Qualified Populations of Focus

Under this RFA, GCHP will consider funding applications that address one or more of the following populations of focus. Applications may address more than one population of focus, and the target population may overlap under more than one population of focus category. Please indicate ALL populations of focus that the application addresses, even if the population overlaps in several categories.

- 1. Persons with mental health disorder needs.*
- Persons with substance use disorder needs.*



- 3. Persons with other disabilities.
- 4. Older Adults.*
- 5. Low Income Women .*
- 6. Persons who are homeless.
- 7. Young people from traditionally underrepresented backgrounds.
- 8. Immigrants and families of mixed immigration status.
- 9. Persons with limited English proficiency.
- 10. Low-wage workers and their families or dependents.
- 11. Uninsured children and youth formerly enrolled in Medi-Cal.
- 12. Persons who are in county jail or state prison, on state parole, on county probation, or under post release community supervision.
- 13. Populations affected by the Medi-Cal eligibility expansion.

Applicant organizations must:

- Select at least one of the population of focus (more than one can be listed) listed above and clearly articulate the experience of working with the selected population(s) of focus.
- Identify the population and the geographic area targeted by the proposed project.
- Identify the specific strategies that will be implemented to address the populations of focus.
- Demonstrate how a majority of the individuals that will benefit from the proposed project will be GCHP members.
- Explain how the proposed strategies will be implemented over the course of 12 months.
- Identify the expected outcomes aimed at attaining through the proposed project.
- Provide specific, measurable, attainable, realistic, and time-based goals and objectives.
- Outline the duties and responsibilities of key staff who will be implementing the proposed project.
- Describe how assessment of progress towards attainment of the grant goals and objectives will be measured.

The maximum total award is \$150,000 per organization, with a total amount of funding of \$625,000 for the first year, lasting up to 12 months with a no-cost extension option. The application includes a proposal application narrative, a detailed work plan, a budget and budget narrative, the most recent financial statements for the applicant organization, and a list of the members of the board of directors. All applicants must demonstrate competency, experience with the targeted population, financial stability, business integrity and the ability to successfully implement the proposed project. Applications must include all required

components and be complete at the time of submission to be considered. All application components must be completed using the GCHP provided templates and guidance materials.

V. Use of Funds

GCHP funds may be used for staff salaries and benefits, operating expenses and equipment directly related to the proposed activities. The maximum allowable indirect cost rate is 12.5% of salaries and wages only.

The following types of grants are eligible for funding:

- Project Support (Funding to support a specific, connected set of activities, with a beginning and an end, with explicit objectives and predetermined cost; ongoing projects will be considered.)
- Direct Services (Funding for the provision of services directly to clients, as long as the services are not existing billable services with GCHP.)
- Systemic Change (Funding designed to change the way in which a system or systems operate to improve its functioning.)
- Member journey mapping or other member or community focus group projects.
- Seed Funding (Funding that supports the start-up costs of a new program.)
- Equipment (Funding to be used for laptops, cell phones and / or any other needed equipment to support members in completing their benefit forms, accessing health care or assisting in securing food or essential items.)

Grant funds cannot be used for:

- Providing direct medical care.
- Paying for medical services billable to other payers.
- Services under a different contract or grant program with GCHP.
- Research.
- Endowments and annual fund drives.
- Deficit or debt retirement.
- "Miscellaneous" line items.

VI. Selection Process



All applications will be reviewed by a Review Committee made up of GCHP staff. The Review Committee members may consider a variety of criteria including, but not limited to:

- Organizational background and capacity to address target population(s) of focus and program goals.
- Clear articulation of how selected populations demonstrated need, and alignment with GCHP selected priorities.
- Proposal request is sound and feasible and clearly articulates the roles of collaborative partners and staff.
- Proposal identifies measurable and attainable benchmarks.
- Appropriate budget development, justification and indirect costs.
- Demonstrated capacity to evaluate the project.
- Evidence that a significant number of those benefiting from the proposed project will be GCHP beneficiaries.

All applicants selected for funding will be required to enter into the Grant Agreement provided by GCHP.

VII. Monitoring and Evaluation

During the grant award contract, GCHP will monitor the organizations selected for funding to ensure that they are performing according to the terms of their grant award agreement. Grantees will be required to submit progress reports monthly and quarterly that provide complete and accurate documentation of program activities using forms provided by GCHP. Such documentation must include specific information about the evaluation benchmarks and expenditures to date.

VIII. Application Completion and Submission

Follow the steps below to complete and submit your application. **Incomplete applications** may not be reviewed.

Step 1: Complete Application Forms

Complete the following four application forms, which can be found on the <u>GCHP website</u>. Also, include documents numbered 5-9 as part of your application submission.

- 1. Application Narrative.
- 2. <u>Workplan Attachment A</u>. To complete the Workplan, please refer to the Workplan Guidance Sample Document.
- 3. <u>Budget Attachment B</u>. This includes the budget Tab 1 of spreadsheet; a budget narrative Tab 2 of spread- sheet; and a worksheet identifying other sources of support for the project Tab 3 of the spreadsheet.



- Acknowledgement Attachment C.
- 5. Signed Form W-9.
- 6. 501(c)(3) IRS notification letter.
- 7. Most recent audited financial statements and Tax Form 990.
- 8. Lists of Board of Directors or Board of Governors and senior management staff. Include names, titles, and connections to GCHP. If no connection to GCHP, please write "no connection" next to each name.
- 9. Memorandum of Understanding (MOU) for organizations applying through a fiscal agent.

Step 2: Submit Completed Application Forms and supplemental documents (via email)

You many email your completed PDF application forms and application documents to Grants@goldchp.org.

Step 3: Application Checklist

Please use the <u>Application Checklist Form</u> on the GCHP website to ensure that you have provided all required documents. Missing documents or pages may be considered as an incomplete application and may not be reviewed.

Applications are due by 5 p.m. PST on Sept. 16, 2025.
