

COVERAGE OPTIONS FOR BLOOD PRESSURE MONITORS AND CUFFS

Personal home use blood pressure (BP) monitors and cuffs are covered as a pharmacy benefit under Medi-Cal Rx and as a Durable Medical Equipment (DME) under the Gold Coast Health Plan (GCHP) medical benefit.

Blood Pressure Products Covered	Covered products are restricted to those listed on the List of Covered Personal Blood Pressure Monitoring Devices and Blood Pressure Cuffs.Please check the Medi-Cal Rx Web Portal for the most up-to- date information.	 Covered products include blood pressure devices billed with the following HCPCS codes. A4660 (sphygmomanometer / blood pressure apparatus with cuff and stethoscope) A4663 (blood pressure cuff only) A4670 (automatic blood pressure monitor)

Only one BP monitor covered every five years. One BP cuff covered every 365 days. Wrist BP monitors / cuffs are NOT covered. Effective April 30, 2024, Medi-Cal Rx removed the diagnosis requirement to justify medical necessity. 	 HCPCS codes A4660, A4663, or A4670 must be submitted with an ICD-10-CM diagnosis code that justifies medical necessity (e.g., I10 for Essential Hypertension). These codes are for purchase only. If these codes are billed with modifier RR (rental), the claim will be denied. More information is listed on the <u>Medi- Cal Provider Manuals DME Billing Codes:</u> Frequency Limits. Quantity and billing restrictions apply. Only one BP monitor / cuff device covered every five years.

Prescriptions for BP Monitors	Send the prescription to a pharmacy that accepts Medi-Cal Rx. To locate a pharmacy, check the <u>Medi-Cal Rx Web Portal</u> .	Send the prescription to a <u>DME provider</u> <u>contracted with GCHP</u> and ask them to bill GCHP under the medical benefit.

Rx: Blood Pressure Monitor – Small, Medium, or Large Sig: Use as directed Quantity: #1

Blood Pressure Cuff – Small or Large Sig: Use as directed Quantity: #1

ICD-10-CM diagnosis code*: One that justifies medical necessity for cardiovascular monitoring for a chronic condition or on a regular basis (e.g., 110 for Essential Hypertension)

Refills: none

* Effective April 30, 2024, Medi-Cal Rx removed the diagnosis requirement to justify medical necessity. The diagnosis requirement is still needed for DME coverage.
