CALL TO ORDER

Committee Chair, Ruben Juarez, called the meeting to order at 4:04 p.m. via teleconference. The Clerks were in the Community Room located at Gold Coast Health Plan, 711 E. Daily Drive, Camarillo, California.

PUBLIC COMMENT

Sandra Aldana stated she had heard from members in the community that they are having difficulties getting providers outside of the area for children who need services from specialists. There is difficulty transitioning children and/or adults outside of the area for specialty services. There is lack of coordination with transportation. She is requesting that CAC work with the University Center of UCLA and Children's Hospital of Los Angeles to hold an informative meeting on how to collaborate and coordinate care. Committee Chair Ruben Juarez asked if there was a way to reply to the request. The Clerk stated that a reply could



be done via email or coordinate a meeting with staff. UCLA is outside of the jurisdiction for GCHP.

WELCOMING REMARKS

Nick Liguori, Chief Executive Officer, thanked the committee for their service. He stated that GCHP is working on meeting their mission. There has been significant new capabilities since the last CAC committee meeting. He noted that GCHP is focused on meeting the needs of our community.

GCHP is developing programs, policies, and improved quality of care by analyzing healthcare data to meet the needs of our members. We are developing/modernizing our technologies, which is necessary to provide the services our members need. We now know the risks that need to be addressed. We are gathering information/data to provide the assistance our members need. We are developing highly tailored programs along with incentives. We now have data that we can learn from and act on.

UPDATES

3. Quality Improvement (QI) Update: Gold Coast Health Plan Member Engagement

Staff: Rachel Ponce, Quality Improvement Manager

<u>RECOMMENDATION:</u> Receive and file the update.

Ms. Rachel Ponce reviewed GHCP's member engagement plan to close gaps in care and ensure they receive the care they need. We are launching a texting/secured digital program. The program launched approximately one month ago. The program targets Well-Child visits and Women's Health. The text messages are sent to members with care gaps through a secured digital platform. It includes health education materials, and reminders to schedule appointments.

GCHP currently has a few members incentive programs, which include well-child exams, cervical cancer screening, breast cancer screening, diabetes, and asthma exams. There are other programs that are still in the works.

CMO Nancy Wharfield, M.D. added that the quality of care that members receive are graded – this determines revenue. Plans that do well, will have a better reimbursement. Members need to take advantage of incentives that are being offered.

Committee member Juana Quintal joined the meeting at 4:24 p.m.

Committee member Laurie Jordan asked about Occupational/Physical Therapy (OTPT), she was advised that there are no services available. She asked if there was a known shortage. CMO Wharfield will follow up with Ms. Jordan to discuss barriers.



Committee member Paula Johnson stated she works with a population of 18 and older, she wants to make sure they sign up for reminders on needed services or appointments. Ms. Ponce stated that we are currently targeting women's health, but we are planning to expand the program for other aspects of care, such as diabetes, and other chronic conditions.

Committee member Paula Johnson stated she would like to partner with GCHP to bridge care gaps. She shared that there are clinics throughout Ventura County that would like to partner with staff to get the care needed for individuals who attend her program. She currently partners with the County for flu vaccines. CMO Wharfield will contact Ms. Johnson.

Committee Chair, Ruben Juarez stated the concept of a reminder message is good, even though there might not be a reply, all we can do is hope they follow up and note that the message was sent.

Committee member Pablo Velez asked what language is used in the message. CMO Wharfield explained that the State does give us access to that information. Dr. Velez noted that some members can't read or write, he asked if there was an option for verbal content. Dr. Lupe Gonzalez stated we offer audio and CD cassettes.

4. CalAIM Update

Dr. Lupe Gonzalez stated GCHP is currently preparing for Phase 2: ECM Expansion. She reviewed the timeline for each phase and start dates for the services. She also reviewed the Community Supports services that are available as well as the proposed timeline for additional services.

Beginning January of 2023 various services such as personal homemaker services, respite services, community transition, environmental accessibility adaptions, and nursing facility transition will be added. In July of 2023 asthma remediation will be included and in 2024, day habilitation and sobering centers will be added.

Dr. Gonzalez also reviewed upcoming CalAIM opportunities. She noted that program updates will be provided and information could be found on the GCHP website.

A new initiative started in July of 2022 – Community Health Workers (CHWs) Dr. Gonzalez reviewed the CHW benefit which includes written recommendation from a physician or licensed practitioner. CHWs will also address preventative services, infectious disease, and mental health conditions as well as substance use disorders.

Next steps include working with DHCS to review criteria for CHWs, billing codes, and provide an announcement of the benefit.

Committee member Paula Johnson asked about recuperative care/medical respite. CMO Wharfield stated this is a place to rest, it gives housing, food, etc. and helps someone who is housing of food insecure get stabilized to keep them from going back into the hospital.

SUMMARY/RECOMMENDATION:

At its May 25, 2022, special meeting, the Community Advisory Committee ("Committee") of the Ventura County Medi-Cal Managed Care Commission ("Commission") dba as Gold Coast Health Plan ("Plan") made findings pursuant to Assembly Bill 361 to continue to meet remotely. To continue this practice, it is required, that the Committee determine that the COVID-19 state of emergency proclaimed by the Governor still exists and has been considered by the Committee in deciding to continue to have teleconference meetings and that state or local officials have imposed or recommended measures to promote social distancing in connection with COVID-19, and that as result of the COVID-19 emergency, meeting in person would present imminent risks to the health or safety of attendees. Because these findings must be made every thirty (30) days, it is time to remake the findings.

BACKGROUND/DISCUSSION:

Traditionally, the Brown Act allows for teleconference or virtual meetings, provided that the physical locations of the legislative body's members joining by teleconference are posted on the agenda, that those locations are open to the public and that a quorum of the members is located within its jurisdiction. Newly enacted AB 361 provides an exception to these procedures in order to allow for fully virtual meetings during proclaimed emergencies, including the COVID-19 pandemic.

Since March of 2020 and the issuance of Governor Newsom's Executive Order N-29-20, which suspended portions of the Brown Act relating to teleconferencing, the Commission and the Plan's Committees have had virtual meetings without having to post the location of the legislative body members attending virtually. Most public agencies have been holding public meetings using virtual platforms since this time. In June of 2021, Governor Newsom issued Executive Order N-08-21, which provided that the exceptions contained in EO N-29-20 would sunset on September 30, 2021.



On September 10, 2021, the Legislature adopted AB 361, which allows public agencies to hold fully virtual meetings under certain circumstances without the posting of the agenda from each location a legislative body member is attending. Governor Newsom signed the bill into law on September 16, 2021. Because it contained an urgency provision, it took immediate effect.

Specific Findings Required under AB 361

Under AB 361, the Committee, can hold virtual meetings without providing notice of the Committee's teleconference location if the Committee makes the determination that there is a Governor-proclaimed state of emergency which the Committee will consider in their determination, <u>and</u> one of two secondary criteria listed below exists:

- 1. State or local officials have imposed or recommended measures to promote social distancing in connection with COVID-19; or
- 2. The Committee determines that requiring a meeting in person would present an imminent risk to the health or safety of attendees.

COVID-19 continues to present an imminent threat to the health and safety of Committee members, and its personnel, and the Governor's declaration of a COVID-19 emergency still exists. Although vaccines are now widely available, many people in the State and County are still not fully vaccinated and remain susceptible to infection. The disease can still spread rapidly through person-to-person contact and those in close proximity. Further, more contagious variants of the disease are now present in the State and County, the most predominant of which continues to be the Delta variant. However, another "variant of concern"—the Omicron variant, which has spread rapidly through South Africa and which spurred President Biden's travel ban to several countries in that continent, has also been detected in California. Additionally, several Committee members attend meetings in medical facilities or offices and allowing members of the public to attend meetings at these posted locations when they may not be vaccinated would pose a threat to the health or safety of attendees.

Re-Authorization is Required Within 30 Days

The Committee made the findings listed above at its November 17, 2021, December 15, 2021, January 12, 2022 special committee meetings, January 26, 2022 regular committee meeting and again during its February 23, 2022, March 23, 2022, April 13, 2022 special committee meeting, May 25, 2022, June 22, 2022, special meeting, July 13, 2022 special meeting, July 20, 2022 special meeting, July 27, 2022 regular meeting, August 24, 2022 special meetings of September 21, 2022, October 12, 2022, regular meeting of October 26, 2022, special meetings of November 16,



2022, December 14, 2022, January 4, 2023 and January 25, 2023. Consistent with the provisions of Government Code Section 54953(e), the findings must be made every 30 days "after teleconferencing for the first time" under AB 361. Thus, if the Committee desires to continue to meet remotely without having to post the location of each teleconference location, the Committee must again find that the COVID-19 emergency still exists and that one of the two following findings can be made: that state or local officials have imposed or recommended measures to promote social distancing in connection with COVID-19, or, that a result of the COVID-19 emergency, meeting in person would present imminent risks to the health or safety of attendees.

It is recommended that the Committee make these findings.

CONSEQUENCES OF NOT FOLLOWING RECOMMENDED ACTION:

The Committee will have to follow the Brown Act provisions that existed prior to the COVID-19 pandemic.

FOLLOW UP ACTION:

That the Committee make the findings under AB 361 at the March 15, 2022, special Community Advisory Committee meeting.




