

**AMENDMENT TO THE
MEMORANDUM OF UNDERSTANDING**

COUNTY OF VENTURA ON BEHALF OF ITS HUMAN SERVICES AGENCY**

This Amendment (the “**Amendment**”) is made part of and modifies that certain Memorandum of Understanding dated as of May 19, 2026, (the “**Memorandum of Understanding**”), by and between VENTURA COUNTY MEDI-CAL MANAGED CARE COMMISSION, doing business as Gold Coast Health Plan (“**PLAN**”), and County of Ventura on behalf of its human services agency (“**PROVIDER**”). This Amendment shall take effect as of May 19, 2026 (the “**Amendment Effective Date**”)

RECITALS

WHEREAS, PLAN and PROVIDER are parties to the Memorandum of Understanding; and

WHEREAS, PLAN and PROVIDER now desire to amend the Memorandum of Understanding as set forth in the attachment hereto (the “**Attachment**”).

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties agree as follows:

1. **Amendments to the Memorandum of Understanding.** The Memorandum of Understanding is hereby amended as set forth in the Attachment, which is incorporated herein by reference and made part of this Amendment.

2. **No Other Changes.** Except as expressly set forth in this Amendment, all other terms and conditions of the Memorandum of Understanding shall remain in full force and effect.
