Fuse is a Youth Centre in Sumner run by Shoreline Youth Trust.

It is available for hire for birthday parties and other events during the weekend and school holidays.

Cost: \$60 for venue + \$20 per hour for a supervisor. NB an extra hour for supervisor is charged for setup/ Clean up.

Facility Size: Fuse can accommodate up to 40 people. If it's a kid's birthday party then sufficient parent help is needed.

What Fuse has: X box & games, Playstation 3 & games, Singstar, Band Hero, Foosball, Pinball, Dart Board, Board Games, Couches, tressel tables, sound system, heatpump.

Kitchen facilities are also available with fridge, oven, microwave & Zip. **NB: No R16 or R18 Xbox/PlayStation games.**

Food: You are welcome to bring your own food & drink but you will need to bring your own plate, cutlery & cups.

We have a shop which sells lollies, drinks and juicies. This can be open by prior request from hirer.

Rubbish: You must take all your rubbish with you.

Fuse Youth Centre Hire Terms and conditions

DEFINITIONS

Event means the purpose for which the venue is to be hired as described by you in the Venue Hire Agreement.

Hirer means the person named as Hirer in the Venue Hire Agreement and is referred to as you in these terms and conditions.

Venue Hire Agreement means the agreement attached to these terms and conditions, together with these terms and conditions.

NATURE OF THE EVENT

By signing the Venue Hire Agreement you warrant and agree that the Event is accurately and comprehensively described in the Venue Hire Agreement.

You also warrant and agree that Fuse will not be used by you for any activity that is of an objectionable nature.

TERMS OF PAYMENT

You will pay Shoreline youth trust the full amount owed on the day of the hire unless organized prior to the event.

ADDITIONAL CHARGES

In addition to the Venue Hire Price, you will be charged for:

1. Any damage to the Venue during the Hire Period caused by you, or arising due to your lack of care or any other breach of these terms and conditions;
2. Any theft of Shoreline youth trusts property from the Venue during the Hire Period
3. If you use the facility longer than stated in the venue hire agreement. You will be charged for the extra time you are present at the venue.

USE OF THE VENUE

You may only use the Venue in accordance with the description of the Event and/or Venue use provided by you to Shoreline Youth Trust.

You shall remove all goods and rubbish brought to the Venue at the end of the Event.

You shall ensure that all persons attending the Event have vacated the Venue by the finish time stated in the Hire Agreement.

The maximum number of people that can be admitted to your Event is 40. You must ensure that the number of people in the Venue does not exceed the maximum number.

Shoreline Youth Trust will ensure that it has one Supervisor on duty for the duration of the Hire Period. If the number attending exceeds 40 you will need another supervisor and you will need to cover costs for them.

You must comply with all lawful and reasonable directions of Shoreline Youth Trust staff member (s) at all times.

In respect of the Venue you must:

1. Protect all floors, walls and doors at all times.
2. Take proper care of the Venue and ensure that no damage occurs
3. Not drive nails, tacks, screws or pins into walls, furnishings, floors and ceilings.
4. Not use any of the Venue's equipment, fixtures, fittings, heating or ventilation systems other than for their intended purpose.
5. Not deposit any substance in the toilets, sinks or drains that could cause blockage or damage.
6. Not sell or consume alcohol at or outside the Venue
7. Not smoke anywhere inside the Venue. Smoking is only permitted outside the venue
8. If any damage is caused to the Venue or any property of Shoreline Youth Trust within the Venue, you must immediately notify the Supervisor of the damage in order that Shoreline Youth Trust can arrange for the damage to be repaired, such repair to be at your cost.

LIABILITY

You indemnify Shoreline Youth Trust against all claims, demands, losses, damages, costs and expenses arising from your use or hire of the Venue or any breach of any of these terms or conditions.

Shoreline Youth Trust is not responsible for loss or damage to any of your property in or around the Venue.

Shoreline Youth Trust is not liable for any loss or expense that you incur if Shoreline Youth Trust is not able to make the Venue available to you as a result of fire, flood, earthquake, failure or other unavailability of any building services or other event beyond Shoreline Youth Trusts reasonable control.

CANCELLATION OF EVENT

If you cancel the Event please notify Shoreline Youth Trust ASAP. If not notified within two hours of start time fee of \$60 will still be charged.

Shoreline Youth Trust may cancel this Hire if a breach of the terms and conditions happens.

GENERAL

You must comply, at your own expense, with all applicable statutes, regulations, bylaws, consents, these terms and conditions and Shoreline Youth Trusts policies and procedures as they relate to the use, occupation, safety and security of the Venue.

You cannot transfer any of your rights or obligations under this Venue Hire Agreement.

These terms and conditions shall apply to you, guests and invitees and you are responsible for ensuring compliance by such persons with these terms an
