Detention

All NCL containers 7 days free. € 10 per TEU per day thereafter.

1 TEU empty **shipper-owned container**: 5 days free. Day 6-20 € 10 per day. € 15 per day thereafter.

2 TEU empty **shipper-owned containers**: 5 days free. Day 6-20 € 15 per day. € 20 per day thereafter.

Surcharges:

Plug-in charge: € 50 (single fee)

Consumption charge: 4 days free. € 100 per day thereafter.

Ventilated container charge: 4 days free. € 80 per day thereafter.

2 TEU full **NCL and shipper-owned**: 2 days free. Day 3-6 € 70 per day. € 130 per day thereafter.

1 TEU empty **shipper-owned**: 5 days free. Day 6-20 € 20 per day. € 40 per day thereafter.

2 TEU empty **shipper-owned**: 5 days free. Day 6-20 € 35 per day. € 70 per day thereafter.

Detention (only for NCL containers)

All NCL containers € 10 per TEU per day.

Consumption charge: 2 days free. € 100 per day thereafter.

Ventilated container charge: 2 days free. € 80 per day thereafter
