I am writing regarding the Quebec legislature having now passed Bill 29 an amendment to the Consumer Protection Act along with regulations regarding monetary penalties and disclosure requirements regarding parts availability, service availability and service manual availability.

Danby has a longstanding commitment to supporting our products well beyond the point of sale. While Danby does not guarantee availability of all parts indefinitely, service manuals for every model, or availability of service technicians in all areas, Danby takes pride in maintaining a robust inventory of parts for a reasonable length of time as well as offering reliable service solutions to ensure our customers receive the high level of support they expect. We also provide a variety of warranty options to *Do the Right Thing*.

Our compliance approach includes the following:

- **Transparent Disclosure**: Provide clear statements pertaining to availability of (i) replacement parts, (ii) authorized repair services, and (iii) relevant maintenance information
- **Consumer Accessibility**: Include a hyperlink on product packaging, and online marketing in a prominent manner that will direct consumers to the disclosure information.
- Ongoing Oversight: Internal processes to regularly review and update this information to ensure ongoing alignment with regulatory changes.

As part of Bill 29 and the associated regulations, the Quebec government requires retailers and manufacturers in the province to:

79.18 ...the manufacturer must disclose in a prominent and comprehensible manner, online if he entirely or partially or in no way guarantees the availability of each of the following elements: a) replacement parts; b) repair services; c) information necessary to maintain or repair the goods. **79.19** ...the merchant must, before entering into a contract, disclose **in writing**, in a prominent and comprehensible manner, if he entirely, partially or in no way guarantees: a) replacement parts; b) repair services; c) information necessary to maintain or repair the goods. ...if the merchant partially guarantees the availability of any one of those elements, he must also disclose in the same manner, the information making it possible to easily identify the replacement parts, repair services or information necessary to maintain or repair the goods...
