# Location

Lenziemill Industrial Estate is located to the south of Cumbernauld less than 1 mile from the town centre.

Cumbernauld occupies a key location at the hub of central Scotland's motorway and major road network, providing access to Glasgow, Stirling and Edinburgh. Access to the M80 is achievable in 8 minutes via the A73.

# Description

The premises comprise a detached industrial unit of steel portal frame construction with block work infill under a pitched roof incorporating translucent roof panels. Access is provided via a number of pedestrian entrances to the front and 3 roller shutter doors, with two accessed through a secure yard area. Internally there two toilet blocks offering male and female facilities. The premises has been constructed in a way which would accommodate subdivision.

Externally there is a secure yard area and open plan parking which could be used to further expand the vard.

- 3x vehicle access doors approximately 3.1m high and 3.8m wide
