

HEATHROW CARGO TERMINAL

- 185 destinations in 84 countries and growing
- + 472,067 air transport movements in 2015
- Heathrow Cargo Terminal handled 1.5 million metric tonnes of airfreight in 2015 increasing further in 2016
- Expanding specialist cargo solutions particularly in perishables and pharmaceuticals
- In November Heathrow Airport Authority announced a £180 million investment programme to the Cargo Terminal to double cargo volumes

- UK government has approved a third runway at Heathrow Airport – the first full length runway in the south-east since the 1940's
- A new runway at Heathrow will bring economic benefits to passengers and the wider economy estimated at up to £61bn, the Government has stated, creating up to 77,000 additional local jobs


