

The property is situated on the western side of Cardiff within walking distance of the city centre and Cardiff central bus and train station, as well as being in close proximity to Sophia Gardens and nearby amenities located on and around Cathedral Road.

## **Description**

The Castlebridge development, which was completed in 1989, is a purpose built development of five self-contained office buildings, all of which are situated around an attractive central courtyard area. The buildings provide a total of 54,736 sq ft of office accommodation over ground and three upper floors.

The property provides good flexibility of accommodation, enabling subdivision and interconnection accordingly. The specification of the property comprises:


