#### Location

Bonnington Industrial Estate is situated at Elizafield, only 2 miles north of Edinburgh City Centre and 1/2 a mile from Leith. Elizafield is accessed off Newhaven Road close to its junctions with Bonnington Road, and Pilrig Street. Units 7 and 8 are located next to SRS Vehicle Components at the rear of the estate on the right hand side.

#### Description

The premises comprise a high quality warehouse unit of concrete framed construction with part rendered brick elevations, beneath a profiled asbestos cement roof incorporating new translucent roof panels providing excellent natural light. The unit provides an open plan warehouse with WC's and a small kitchen.

The maximum eaves height is 6.6 m, there is a 3 phase power supply and a capped gas supply is located immediately adjacent to the unit.

There is a loading area to the front of the property, and there is a new electrically operated roller shutter vehicular access door measuring 4m wide by 4.2m high. Additionally, there are 6 car parking spaces allocated to the unit.
