Overview

A new office tower designed by PLP in the heart of the tower cluster and due for completion to a top specification in July 2019.

The 61 storey tower comprises 1.275 million sq ft of Grade A office accommodation. Floors are available on lease terms by arrangement from the owners. There will also be 100,000 sq ft of amenity space within the building including a Food Market, Innovation Hub, Gym, Relaxation and Wellbeing Centre and a Members Club.

- 1:8 sq m occupation density throughout
- Base build plus separate dedicated cooling available on demand without additional tenant plant
- 1,113 bicycle spaces, 1,846 lockers and 128 showers
- 24 x double decker passenger lifts and 3 x single decker passenger lifts
- 3 x 3,000kg good lifts serve all floors
- Dual power feed from two separate substations
- Standby generators- 12MVA
