Location

Tavistock lies on the south-west edge of Dartmoor National Park , about 24 km (15 miles) north of the maritime city of Plymouth.

The Property is accessed from Tavistock Town Centre where there is a popular retail centre. The office market is centred on the Plymouth Road with the Council Offices located next to the old station and viaduct.

The property is located on Plymouth Road adjacent to the Quayside car park and Meadowlands Leisure Centre in Tavistock opposite the Bus Station.

Adjacent to the Offices is the Town Library.

Description

The property three storey constructed of masonry rendered with a brick plinth under a pitched slate roof with double glazed wooden windows units.

It has a self-contained entrance off the main car park in front of the building






