Forest Trading Estate is situated on Priestley Way, close to Blackhorse Lane (B179). 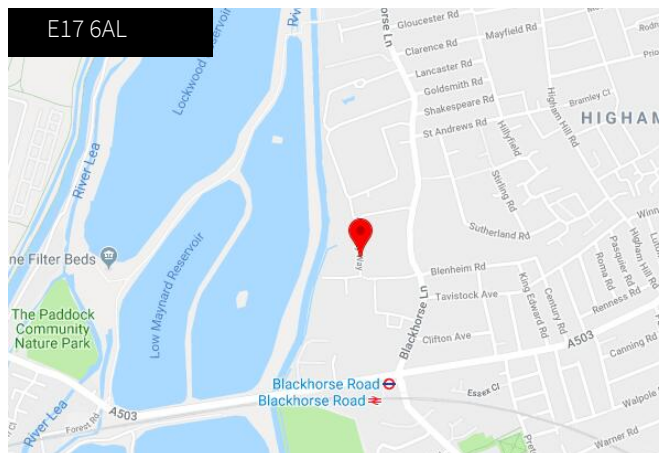
