# Location

St Peter's Road is situated on the established Furze Platt Industrial Estate, approximately 1 mile north of Maidenhead town centre. Access to the motorway network is gained via the A308 and A404 which links the M4 motorway (Junction 8/9) with the M40 motorway (Junction 4).

# Description

Genesis offers a modern industrial/warehouse unit that has recently been refurbished. The unit is constructed from a clear span steel portal frame with brick and metal cladding. Externally the unit benefits from ample car parking and large yard area.
