Official Rules

Additional Prize Conditions

4. The Prize and all elements of the Prize must be redeemed and all travel completed between 1 March 2026 and 30 September 2026, or it will be forfeited. If forfeited, the Promoters will not be liable.

6. The Prize is subject to any additional terms and conditions imposed by the Promoters, and any third-party operators, including conditions related to claiming, booking, and participation in the Prize. All activities are subject to availability and must be booked in advance.
7. The Winner/s are responsible for all other unspecified costs related to the Prize (for instance, any insurance, etc).

Unclaimed Prize

12. All reasonable efforts will be taken to contact the Winner, however the Promoters take no responsibility for unread, undelivered or incorrectly provided information.
13. If the Prize has not been accepted or claimed, or if, after making all reasonable attempts, the Winner cannot be contacted and the Prize remains unclaimed within one (1) month from the Prize Draw Date, the Winner will be deemed to have forfeited the Prize and will have no further claim.

Releases

14. To the extent permitted by law, by entering this Competition, you agree to release, discharge, indemnify, and hold harmless the Promoters, and their respective directors, officers, employees, agents, contractors, and affiliates, (collectively, the "**Released Parties**") from any claims, actions, losses, damages, liabilities, costs, or expenses of any kind (including, without limitation, legal costs and expenses on a full indemnity basis) arising out of, or in any way connected with, your participation in this Competition or any Competition-related activities (including, without limitation, attendance at events, travel, or other activities) and the acceptance, use, misuse, or possession of any prize awarded hereunder. This includes, without limitation, any claims arising from: (i) non-compliance by you with these Terms and Conditions; (ii) any malfunction, technical failure, error, delay, or other problem arising in connection with the collection, processing, storage, or retention of entry information; (iii) any typographical or other error in the administration of the Competition or announcement of any winner; (iv) any act or omission of the Released Parties, whether negligent or otherwise, and (v) any personal injury, property loss or damage, or death arising in connection with your participation in the Competition or acceptance or use of any Prize.
15. Nothing in these Terms and Conditions excludes, restricts, or modifies any rights that you may have under the Australian Consumer Law (ACL) or other applicable consumer protection legislation that cannot be excluded, restricted, or modified by agreement. However, to the fullest extent permissible by law, the Promoters and the Released Parties will not be liable for any indirect, incidental, special, punitive, or consequential damages, including but not limited to loss of profits, revenue, goodwill, or opportunity, arising out of or in connection with your participation in the Competition or use or misuse of any Prize, even if the Promoters were advised of the possibility of such damages.
16. As a condition of accepting the Prize, the Winner may be required to sign a legal document, in a form determined by the Promoters at their sole discretion, which may include a release and indemnity. Conditions

18. Entrants consent to the use of their names, likeness or image by the Promoters if they are the winner of the Prize for an unlimited period of time without remuneration. Entrants agree to comply with any reasonable direction of the Promoters in this regard.
19. If, for any reason, this competition cannot run as planned due to events such as war, terrorism, state of emergency, natural disaster, pandemic, computer virus, telephone network failure, unauthorized tampering, fraud, technical failures, or any other cause beyond the Promoter's control, the Promoters reserves the right, at its sole discretion, to cancel, terminate, modify, or suspend the competition, or invalidate any affected entries. This is subject to the approval of relevant authorities, if required. The Promoters will not be liable for any failure or delay in performing its obligations under these Terms and Conditions due to any act, omission, event, or circumstance beyond its reasonable control.
20. The Promoters reserves the right, at any time, to verify the validity of Entrants (including an Entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter have reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Competition.
21. Any entries or nominations that are deemed by the Promoters, in its sole discretion, to be rude, defamatory, offensive, illegal, incomprehensible, incorrect, incomplete, or that breach any law or infringe on third-party rights, including intellectual property rights, will be invalid and may be removed by the Promoter.
22. The Promoters do not knowingly collect personally identifiable information from persons under the age of eighteen (18) years old. Such persons are expressly prohibited from submitting their personally identifiable information to Promoter and any information submitted by such users will not knowingly be used, posted, or retained by Promoter.
23. The Promoter reserves the right to cancel or amend the Competition and these Terms and Conditions if necessary, for reasons outside of its control or as required by law. Any such changes will be communicated to entrants as soon as reasonably possible. Failure by the Promoter to enforce any of their rights at any stage does not constitute a waiver of those rights.
24. If you are a Winner, the Promoters will use your personal information to conduct and manage the Competition. The Promoters may disclose your personal information to its related bodies corporate or to assist in administering the Competition, communicating with you, or storing data. Your personal information will be handled in accordance with the Promoter's and, if applicable Privacy Policy(ies).
25. Without limiting the foregoing, Entrants' personal information provided in connection with this Competition will be handled in accordance with the Privacy Policy and the *Privacy Act 1988*.
26. The laws of Queensland, Australia apply to these Terms and Conditions and the parties submit to the exclusive jurisdiction of the courts of Queensland, Australia.
