1 Request for Procurement

Use templates to create standardised requests. Templates can be published on your website or on the portal.



Requests can be closed, and converted to a procurement plan, transferring information from one step to the next.

2 User Roles & Rights

Accept, reject, and modify requests.
Accepted requests become planned procurement activities.



Inquiries and direct messaging is used to communicate with internal stakeholders and external parties.

3 Overview of Request Workflow

Gain a complete list of all incoming requests, from single sourcing events to complex categories.



The procurement plan allows you to: work dynamically in the planning phase, set up calendars, assign permissions, and add products. Once the planning phase is completed, tenders can be created directly from the plan, and the information is carried forward into the tender.






