

## WINKEL WETOXWELD(NON TOXIC)

**WINKEL WETOXWELD** is a gel product properly formulated for the pickling of austenitic stainless steels with a low sulfur content.

In particular, it is suitable for the removal of welding, annealing oxides and rust.

In order to achieve a uniform treatment it is advisable to degrease and decontaminate the surface before pickling

(Certification ASTM380, ASTM B117, ASTM967)

## HOW TO USE

WINKEL WETOXWELD should be used as it is. Mix the product to bring it back to its homogeneity, using a plastic or a stainless steel rod, never of iron. Apply on surface by an acid-resistant brush free from metallic parts and wait until the product reacts (it turns to pale green colour). Do not apply the product on hot surface (> 35 °C). The time for a good pickling varies from 10 minutes to more than 2 hours depending on the type of welding, the material to be treated and on the temperature.

Type of welding	Reaction time (min)
TIG	10-45
MIG	>60
ELECTRODE	>120

Once the reaction time has elapsed, wash thoroughly with cold and clean water if possible under pressure. The washing water must be tap and must not contain iron and chloride ions in concentration higher than 70 mg / l (conductivity  $\chi$ < 450 µS). AFTER Pickling you should proceed with the passivation of the surface in order to increase the corrosion resistance.
